2 **EXTENDING THE EFFECTIVE HOURS OF THE WHITE ZONE IN FRONT OF 1200**
3 **CALIFORNIA STREET TO 24 HOURS**

4 WHEREAS, There is an existing 40-foot white zone on the north side of California
5 Street, from Jones Street to 40 feet westerly; and,

6 WHEREAS, The white zone is located in front of 1200 California Street, a 91-unit high
7 rise apartment building; and

8 WHEREAS, The white zone is currently effective during the standard hours of an
9 apartment building white zone, 7am to 10 pm daily, and general parking is available at other
10 times; and,

11 WHEREAS, Between the hours of 10pm and 7am, vehicles must double park to load
12 and unload passengers; and,

13 WHEREAS, The apartment building is located immediately beyond the crest of a hill
14 and double parking on the crest of the hill poses a traffic and safety hazard; and

15 WHEREAS, The Board of Directors of 1200 California Cooperation requested that the
16 white zone be made effective 24 hours a day; and

17 WHEREAS, The Parking and Traffic Commission approved the proposal to extend the
18 effective hours to 24 hours a day on December 15, 1998;; now therefore, be it;


