3 **Ordinance amending the Administrative Code to extend the sunset date for the**
4 **Pedestrian Safety Advisory Committee by one year, to October 1, 2020, and requiring**
5 **the Committee to recommend changes to its structure and duties.**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. Article IV of Chapter 5 of the Administrative Code is hereby amended by
15 revising Sections 5.4-2 and 5.4-3, to read as follows:

16 **SEC. 5.4-2. DUTIES OF THE COMMITTEE.**

17 * * * *

18 (b) By no later than May 1, 2020, the Advisory Committee shall submit to the Board of
19 Supervisors a report recommending possible changes to the structure, duties, or member qualifications
20 of the Advisory Committee.

21 **SEC. 5.4-3. SUNSET.**

22 Unless the Board of Supervisors by ordinance extends the term of the Advisory
23 Committee, this Article IV shall expire by operation of law, and the Advisory Committee shall
24 terminate, on October 1, ~~2019~~2020. After that date, the City Attorney shall cause this Article to
25 be removed from the Administrative Code.

2 Section 2. Effective Date; Retroactivity.

3 (a) This ordinance shall become effective 30 days after enactment. Enactment
4 occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or
5 does not sign the ordinance within ten days of receiving it, or the Board of Supervisors
6 overrides the Mayor's veto of the ordinance.

7 (b) This ordinance shall be retroactive to October 1, 2019. It is the intent of the
8 Board of Supervisors that, during the period between October 1, 2019 and the effective date
9 of this ordinance, the Advisory Committee shall continue to operate without interruption, and
10 that the incumbent members of the Advisory Committee shall continue to hold their seats
11 without reappointment unless displaced or removed in accordance with Section 5.4-1 of the
12 Administrative Code.

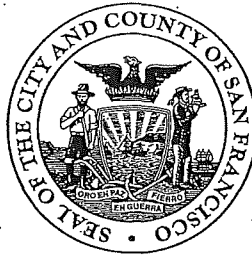

14 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
15 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
16 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
17 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
18 additions, and Board amendment deletions in accordance with the "Note" that appears under
19 the official title of the ordinance.
