City Attorney's Role

- We are lawyers for the City officeholders, departments and governing bodies.
- Our work serves all communities in San Francisco, with a particular focus on the most vulnerable: including communities of color, LGBTQ+, seniors, and children.
- Nearly every team in our office does work that supports equity and vulnerable populations in San Francisco.
- We are investigating and uncovering waste, fraud or abuse of taxpayers dollars.
- We are doing critical work at nearly every level of pandemic response.

Serving vulnerable communities

- Defeated the Trump administration in court to protect \$2 billion for food assistance, health care, housing and other programs that primarily help seniors, low-income residents, working families and other vulnerable communities.
- Blocked federal rule that would have allowed discrimination in health care, particularly against the LGBTQ+ community, women, and other vulnerable populations
- Won court victories for three ballot measures that would free up millions annually for:
 - homeless services and supportive housing (\$300M)
 - public schools and their educators (\$50M)
 - childcare and early childhood education for working families (\$150M)

Housing and Homelessness

Protect low-income tenants

- successfully defended SF's eviction moratorium in court
- won the first decision of its kind in the state that prohibits landlords from discriminating against people using housing vouchers

Creating affordable housing

- Our office works on the planning, development, leasing, financing and construction of private and public housing, including:
 - navigation centers
 - 100% affordable housing projects
 - inclusionary housing and mixed-use projects with high affordable housing percentages
 - rehabilitation and reconstruction of existing public housing under the RAD program and HOPE SF
 - small sites for the preservation of affordable housing
 - various rental and homeowner assistance programs
- Defeated lawsuit that sought to stop the Embarcadero Navigation Center

Pandemic Response

- Draft and execute all Declarations of Emergency, Health Orders, Emergency Ordinances and Mayoral Emergency Orders.
- Handle emergency contracts to secure PPE, thousands of hotel rooms and related services for the homeless
- Provided at least 16 employees to do culturally competent contact tracing to address the COVID-19 spread in vulnerable communities, especially communities of color
- Advising the City's Economic Recovery Task Force
- Working with the Controller and City Administrator on Give2SF
- Central role on health order education and enforcement
- Addressing myriad new legal questions and issues arising from this public health emergency, as well as handling numerous drafting requests for ballot initiatives and legislation

Changes from FY 19-20

- FTEs remain essentially unchanged. The increase of 1.42 is due to the annualization of previous year's positions
- \$500,000 reduction in our Affirmative Litigation budget
- Cost increases are due to mandated salary and fringe benefits and increase in litigation costs, which are driven by client needs
