[Contract with California Youth Authority for Diagnostic and Treatment Services for Juvenile Wards of the Court]

Resolution authorizing the Chief Probation Officer of the Juvenile Probation Department to renew a contract with the California Youth Authority for diagnostic and treatment services and for temporary detention not to exceed 90 days.

WHEREAS, From time to time, the Juvenile Court may determine that proper disposition of a case requires diagnosis and treatment at a Youth Authority facility; and,

WHEREAS, After the Juvenile Court has determined that a juvenile ward of the Court is eligible for temporary detention and maximum observation not to exceed 90 days; and,

WHEREAS, The California Youth Authority has agreed to provide temporary detention of a Juvenile ward of the Court for diagnostic and treatment services not to exceed 90 days; and,

WHEREAS, The term of this contract shall be from July 1, 2000 to June 30, 2001; and,

WHEREAS, The County agrees to reimburse CYA an amount not to exceed \$3993 per month for each juvenile ward referred and authorized by the Juvenile Court only, or \$250,000 for the fiscal period above which

1 shall be paid for from the Probation Services Division Maintenance of
2 Minors Appropriation within the budget of the Juvenile probation
3 Department; and,

4 WHEREAS, The Juvenile Probation Commission reviewed and
5 approved the resolution on 2/6/01: now, therefore, be it

6 RESOLVED, That the Board of Supervisors hereby approves
7 Resolution 213-01, authorizing the Chief Probation Officer to renew a
8 contract with the California Youth Authority for Juvenile Court referrals
9 only for the period July 1, 2000 to June 30, 2001, said contract subject to
10 review and extension by the Juvenile Probation Commission; and, be it


12 FURTHER RESOLVED, That although the City has incurred no legal
