7 WHEREAS, The Public Works Director is authorized to revoke flower-vending stand
8 permits pursuant to Public Works Code, Section 162; and

9 WHEREAS, The Public Works Director, in Public Works Order No. 186054, dated June
10 22, 2017, following a public hearing regarding the revocation of the flower-vending stand
11 permit authorizing placement and operation of a flower-vending stand on the sidewalk at 250
12 Post Street, and upon consideration of the facts and testimony presented at the hearing, the
13 Public Works Director accepted the recommendation of the hearing officer to revoke the
14 subject flower-vending stand permit; and

15 WHEREAS, Public Works Order No. 186054 is on file with the Clerk of the Board of
16 Supervisors in File No. 170889 and is incorporated herein by reference; and

17 WHEREAS, On July 19, 2017, Harold Hoogasian filed a timely appeal to the decision
18 of the Public Works Director; and

19 WHEREAS, On September 26, 2017, this Board held a duly noticed public hearing to
20 consider the appeal of the flower-vending stand permit by Appellant; and

21 WHEREAS, This Board has reviewed and considered the subject flower-vending stand
22 permit revocation, the appeal letter, and the other written records before the Board of
23 Supervisors, and heard testimony and received public comment regarding the flower-vending
24 stand permit revocation; now, therefore, be it
