3 Ordinance authorizing settlement of the lawsuit filed by Tyler Francis O'Connor against
4 the City and County of San Francisco for \$125,000; the lawsuit was filed on
5 May 17, 2017, in San Francisco Superior Court, Case No. CGC-17-558989; entitled Tyler
6 Francis O'Connor v. City and County of San Francisco; the lawsuit involves alleged
7 personal injury from vehicle collision.

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Tyler Francis O'Connor v. v. City and
12 County of San Francisco, San Francisco Superior Court, Case No. CGC-17-558989 by the
13 payment of \$125,000. The lawsuit involves alleged personal injury from vehicle collision.


14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 May 17, 2017, and the following parties were named in the lawsuit: plaintiff: Tyler Francis
16 O'Connor; defendant: City and County of San Francisco.


