3 **Resolution Adopting the Telecommunications Plan, as Adopted and Forwarded by the**
4 **San Francisco Telecommunications Commission, as the City's Telecommunications**
5 **Plan.**

7 WHEREAS, The Administrative Code requires the Telecommunications Commission to
8 evaluate City policies and procedures affecting the provision of telecommunications services
9 and the installation of telecommunications facilities within the City and to develop a City
10 Telecommunications Plan; and

11 WHEREAS, The Telecommunications Commission, working closely with the
12 Department of Telecommunications and Information Services, has developed a
13 Telecommunications Plan based on significant research and public participation, including
14 input from local residents, businesses, non-profits, institutions, community organizations,
15 telecommunications providers and City departments; and

16 WHEREAS, The Plan addresses the telecommunications needs of the community,
17 businesses, and local government; and

18 WHEREAS, The Plan proposes City policies and procedures to guide the installation of
19 telecommunications facilities in the City; and

20 WHEREAS, The policies and procedures proposed are intended to facilitate
21 deployment of new technologies in the City, maximize the availability of telecommunications
22 services to City residents, businesses, and departments, preserve City property and
23 resources, and protect the health, safety and welfare of City residents; and

24 WHEREAS, The Plan therefore satisfies the requirements set forth in the
25 Administrative Code; and

1 WHEREAS, The Plan also establishes an overall telecommunications strategy for the
2 City; and

3 WHEREAS, The Plan answers important public questions related to internal and
4 external telecommunications policy; and

5 WHEREAS, The Plan serves as a framework for telecommunications related decision
6 making; and

7 WHEREAS, The Plan provides a way to check the progress of telecommunications
8 initiatives; and

9 WHEREAS, The Plan guides the development of implementation plans and budgets for
10 telecommunications initiatives; and

11 WHEREAS, The Plan therefore provides benefits, above and beyond those required by
12 the Code; and

13 WHEREAS, the San Francisco Telecommunications Commission unanimously
14 adopted the Telecommunications Plan on November 16, 2001; and

15 WHEREAS, the secretary of the Telecommunications Commission submitted the Plan
16 to the Mayor and the Board of Supervisors for adoption as the City's Telecommunications
17 Plan; now, therefore, be it

18 RESOLVED, That the Board of Supervisors hereby adopts the Telecommunications
19 Plan, as adopted and forwarded by the San Francisco Telecommunications Commission, as
20 the City's Telecommunications Plan.
