5 **Victims of Crime and Restitution Program, for a project entitled "Criminal Restitution**
6 **Compact" for the period of July 1, 2001 through June 30, 2002.**

8 WHEREAS, The District Attorney and the City and County of San Francisco desires to
9 enter into an agreement with the State Board of Control Victims of Crime and Restitution
10 Program in accordance with Government Section 13835 for the purpose of ensuring that
11 restitution fines and orders are properly administered; and,

12 WHEREAS, Grant funds received hereunder shall not be used to supplant local funds
13 that would, in the absence of the California Victims of Crime and Restitution Programs, be
14 made available to support the assistance of victims and witnesses of crime; now, therefore, be
15 it

16 RESOLVED, That the District Attorney of the City and County of San Francisco is
17 authorized on behalf of the City and County of San Francisco to contract for, accept and
18 expend funds from the State Board of Control to continue the District Attorney's Contract –
19 Criminal Restitution Compact; and be it

20 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
21 indirect costs in the grant budget; and be it

22 FURTHER RESOLVED, That it is agreed that the District Attorney is authorized to
23 execute on behalf of the City and County of San Francisco the necessary agreements for the
24 Criminal Restitution Compact including any extensions, augmentations or amendments
25 thereof.




