11 France, to be held on July 24, 2005; and,

12 WHEREAS, Armstrong announced he plans to spend more time with his family and  
13 speaking out on behalf of cancer research; and,

14 WHEREAS, This announcement means that San Franciscans and visitors will no  
15 longer be able to see Mr. Armstrong participate in or win the San Francisco Grand Prix, a  
16 City-subsidized bicycle race sponsored by San Francisco Cycling, LLC, a Delaware  
17 corporation, and held here in San Francisco; now, therefore, be it

18 RESOLVED, That the San Francisco Board of Supervisors commends Lance  
19 Armstrong on his stellar career and wishes him well in his final Tour de France; and, be it

20 FURTHER RESOLVED, That the Board of Supervisors declares July 24, 2005 as  
21 "Lance Armstrong Day" in the City and County of San Francisco; and, be it

22 FURTHER RESOLVED, That the Board of Supervisors extends its best wishes to  
23 Lance Armstrong on the occasion of his retirement: and, be it,

24 FURTHER RESOLVED, That the Board directs the Clerk of the Board to forward a  
25 copy of this enacted resolution to Lance Armstrong and San Francisco Cycling, LLC.


