Ordinance authorizing settlement of the lawsuit filed by the People of the State of California against the City and County of San Francisco for \$69,054.66; the lawsuit was filed on August 22, 2025, in San Mateo Superior Court, Case No. 25-CIV-06376; entitled People of the State of California v. City and County of San Francisco; the lawsuit involves alleged violations of the California Hazardous Waste Control Law.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled People of the State of California v. City and County of San Francisco, San Mateo Superior Court, Case No. 25-CIV-06376 by the payment of \$69,054.66. The lawsuit involves alleged violations of the California Hazardous Waste Control Law arising from a July 2023 San Francisco Public Utilities Commission truck spill on a San Mateo County highway.

Section 2. The above-named action was filed in San Mateo Superior Court on August 22, 2025, and the following parties were named in the lawsuit: plaintiff People of the State of California; defendants City and County of San Francisco and San Francisco Public Utilities Commission.
