ORDINANCE NO. **97-04**

1 [Sidewalk Parking Fine Increase]

3 Ordinance amending Article 7, Section 132 of the San Francisco Traffic Code, to  
4 increase the fine for sidewalk parking from \$75.00 to \$100.00 as of ~~January 1, 2004~~  
5 July 1, 2004, in accordance with Resolution No. 648-01, adopted August 17, 2001; to  
6 update the fine for stopping on a freeway because of the repeal of Vehicle Code  
7 Section 25220 and enactment of Vehicle Code Section 21718; and to make various  
8 editorial changes to clarify the Penalty Schedule.

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. Article 7 of the San Francisco Traffic Code is hereby amended by amending  
15 Section 132, to read as follows:

16 **Sec. 132. Penalty Schedule**

17 Pursuant to California Vehicle Code Section 40203.5, violation of any of the following  
18 subsections of the San Francisco Traffic Code (TC), Police Code (PC) or the California  
19 Vehicle Code (VC) shall be punishable by the fines set forth below.







