(1) An assessment was levied by the Board of Supervisor for the City and County of San Francisco, State of California, on defined hotel and short-term rental businesses located within the City and County of San Francisco. The levy of assessment was approved by the Board of Supervisors on September 13, 2022 and signed by the Mayor on September 22, 2022, Resolution No. 381-22. The Assessment Diagram was filed in the Office of the Clerk of the Board of Supervisors for the City and County of San Francisco, on October 13, 2022

Resolution No. 381-22, together with the statutorily required Management District plan (including Appendices) for this District as also approved by the Board of Supervisors, are on file with the Board of Supervisors and are submitted with the Assessment Diagram to the Office of the Assessor-Recorder for the City and County of San Francisco for recording. Reference is made to the Management District Plan and Assessment Diagram, for the amount of each assessment levied against each defined hotel and short-term rental business shown on this Assessment Diagram. The Tourism Improvement District includes all hotel and short-term rental businesses generating revenue from tourist rooms that operate in the City and County of San Francisco during the term of the District, including tourist hotel and short-term rental businesses that first open for business after the adoption of Resolution No. 381-22 and operate during that term.

Upon recordation by the County Assessor-Recorder, a conformed copy of the Assessment Diagram will be filed with the Clerk of the Board of Supervisors for the City and County of San Francisco, and a Notice of Assessment will be issued pursuant to California Streets and Highways Code § 3114 and 36627
