12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
13 authorizes the City Attorney to settle the action entitled Archdiocese of San Francisco Parish
14 and School Juridic Persons Real Property Support Corporation v. City and County of San
15 Francisco, San Francisco Superior Court, Case No. CGC-25-623430 by the payment of
16 \$247,500. The lawsuit involves alleged property and economic damages arising from the
17 March 27, 2023, break of a San Francisco Public Utilities Commission water transmission
18 pipeline at or near the intersection of Gough Street and Ellis Street.

19 Section 2. The above-named action was filed in San Francisco Superior Court on
20 March 19, 2025, and the following parties were named in the lawsuit: Archdiocese of San
21 Francisco Parish, School Juridic Persons Real Property Support Corporation and City and
