18 library materials with those program funds after the first year, the State Library wishes to provide
19 funding to support efforts to renew and update collections of literacy related materials, and

22 educational and economic advancement of our community, and

23 WHEREAS, The San Francisco Public Library has a goal of providing free and equal




BOARD OF SUPERVISORS




