

1 GRANTING REVOCABLE PERMISSION TO SAN FRANCISCO UNIVERSITY HIGH SCHOOL TO  
2 INSTALL THREE (3) 3-INCH UNDERGROUND CONDUITS ACROSS WASHINGTON STREET TO  
3 PROVIDE INTERNET ACCESS TO THE SCHOOL'S BUILDINGS AT 3065 JACKSON STREET  
4 (BLOCK 982, LOT 34) AND 3185 WASHINGTON STREET (BLOCK 999, LOT 26) AND ADOPTING  
5 FINDINGS PURSUANT TO PLANNING CODE SECTION 101.1

8 RESOLVED, That permission, revocable at the will of the Board of Supervisors and  
9 automatically terminating upon failure to continue in force the insurance protection hereafter referred to,  
10 is hereby granted to San Francisco University High School to occupy a portion of the street area, under  
11 Washington Street, between Lyon and Baker Streets, for the purpose of installing and maintaining three  
12 conduits for internet access to the school's buildings as shown on the plan, a copy of which is on file in  
13 the office of the Clerk of the Board of Supervisors..

14 FURTHER RESOLVED, That the project intended by the encroachment is consistent with the  
15 eight priority policies of City Planning Code Section 101.1; in that:

- 16 1. The project is for the installation of conduits under Washington Street for providing  
17 internet access to San Francisco University High School, and will have no adverse effect  
18 on neighborhood serving retail uses or opportunities for employment in or ownership of  
19 such businesses.
- 20 2. The project would have no adverse effect on the City's housing stock or on neighborhood  
21 character.
- 22 3. The project would have no adverse effect on the City's supply of affordable housing.
- 23 4. The project would not result in commuter traffic impeding MUNI transit service or

1                   overburdening the streets or neighborhood parking. Any service delays to traffic would  
2                   be limited to the construction period.

- 3                   5. The project would not adversely affect the industrial or service sectors or future  
4                   opportunities for resident employment or ownership in these sectors.
- 5                   6. The project would not adversely affect achieving the greatest possible preparedness against  
6                   injury and loss of life in an earthquake. The undergrounding of wiring currently located  
7                   overhead between two buildings would result in a safer environment in a seismic event.
- 8                   7. The project would have no adverse effect on landmarks or historic buildings. The Project  
9                   would remove wiring from a building designated in Here Today and would result in the  
10                  elimination of visual blight and clutter which currently exists on an architecturally  
11                  significant building.
- 12                 8. The project would have no adverse effect on parks and open space or their access to  
13                  sunlight or vistas.

14                 PROVIDED HOWEVER, That this permission shall not become effective until:

- 15                 [a] There shall have been executed and acknowledged by the Permittee; and by it delivered  
16                 to the City's Controller, who shall have had recorded in the office of the County Recorder  
17                 a street encroachment agreement, a copy of which is on file with the Clerk of the Board  
18                 of Supervisors in File No. 98-1420 and which is hereby declared to be a part of  
19                 this resolution as if set forth fully herein, and the copy of this resolution attached thereto  
20                 as Exhibit A.
- 21                 [b] There shall have been delivered to the Controller the policy of insurance provided for in  
22                 said agreement and the Controller shall have had approved same as complying with the  
23

1 requirements of said agreement. The Controller may, at his option accept, in lieu of said  
2 insurance policy, the certificate of an insurance company certifying to the existence of  
3 such a policy.

4 FURTHER PROVIDED, That the Permittee, in accordance with Government Code Section 4216.1,  
5 shall become a member of, participate in, and share in the costs of Underground Service Alert - Northern  
6 California (U.S.A.) regional notification center.

7 FURTHER PROVIDED, The rights granted here do not constitute a cable TV franchise and do  
8 not authorize transmission of video programming over City right-of-way or any other signals that would  
9 constitute Cable TV service.

10 FURTHER PROVIDED, The Permittee, at the permittee's sole expense, and as is necessary as a  
11 result of this permit, shall make arrangements: [1] to provide for the support and protection of facilities  
12 belonging to the Department of Public Works, public utility companies, the San Francisco Water  
13 Department, the San Francisco Fire Department and other City departments; [2] to remove or change the  
14 location of such facilities and provide access to such facilities for the purpose of constructing,  
15 reconstructing, maintaining, operating or repairing such facilities.

16 FURTHER PROVIDED, That the Permittee shall procure the necessary permits from the Permit  
17 Bureau and/or Bureau of Street-Use and Mapping, Department of Public Works, and pay the necessary  
18 permit fees and inspection fees before starting work.


19 FURTHER PROVIDED, That the Board of Supervisors reserves the right to exact a permit fee,  
20 or rental, for the use of said street areas for the purpose of performance of its governmental or proprietary  
21 activities, including the constructing, reconstructing, maintaining, operating, repairing, removing and use  
22 of public utilities located under, over or along said street area;


FURTHER PROVIDED, That no structure shall be erected or constructed within said street right-of-way except as specifically permitted herein;




