11 years of dedicated service; and

12 WHEREAS, Through its Intensive Family Reunification  
13 Program, this Agency has provided birth parents with intensive  
14 counseling and support services, and has reunited seventy-five  
15 percent of their client children with parents or relatives; and

16 WHEREAS, Sojourner Truth's Family Resource Center offers a  
17 variety of treatment and support services to the community of  
18 foster children, birth parents, and foster parents, with the  
19 noble goal of intervening early enough to alleviate the trauma  
20 of displacement; and

21 WHEREAS, The Agency has certainly lived up to its namesake,  
22 the famed freed slave, abolitionist Sojourner Truth who  
23 dedicated her life to freedom and justice for African Americans;  
24 now, therefore be it
