18 application be approved with conditions; now, therefore, be it

19 **RESOLVED, That in accordance with Section 23958.4 of the California Business**  
20 **and Professions Code, the Board of Supervisors of the City and County of San**  
21 **Francisco hereby determines for the foregoing reasons that the transfer of a Type 20**  
22 **off-sale beer and wine alcoholic beverage control license from 3237 Pierce Street to**  
23 **2113 Chestnut Street and the issuance of a Type 42 on-sale beer and wine public**  
24 **premises license to Greg O’Flynn for California Wine Merchant, will serve the public**  
25 **convenience and necessity of the people of the City and County of San Francisco.**

1           Conditions: (1) Petitioner shall regularly police the area under their control in an  
2 effort to prevent the loitering of persons about the premises; (2) The petitioner shall be  
3 responsible for maintaining free of litter the area adjacent to the premises over which  
4 they have control.
