
5 MOVED, That the certain map entitled "Map of Le Conte Circle", being a subdivision of Lot 40,

8 Conte Circle between the City and County of San Francisco and the various persons listed thereon as  
9 subdividers, be and the same is hereby approved and adopted as the Official Map of "Le Conte Circle.

10 FURTHER MOVED, That the S.F. Board of Supervisors accepts on behalf of the Public those  
11 strips of land delineated and designated on the Map of Le Conte Circle as: an Exclusive Public Utility and  
12 Sidewalk Easement (Easement "B") and as an Exclusive Sewer and Drainage Easement (Easement "C").


13 FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own and  
14 incorporates by reference herein as though fully set forth the findings made by the City Planning  
15 Commission, by its letter dated June 24, 1999 that the proposed development is consistent with

17 of the Planning Code.

19 subdivider with all applicable provisions of the San Francisco Subdivision Code and amendments
