

1 [Acceptance of Gift – Parking Authority]
2 AUTHORIZING THE PARKING AUTHORITY TO ACCEPT A GIFT OF ONE HUNDRED AND
3 FORTY THOUSAND DOLLARS FROM THE UPTOWN PARKING CORPORATION, THE
4 DOWNTOWN PARKING CORPORATION, AND THE ELLIS AND O'FARRELL PARKING
5 GARAGE TO FUND A GARAGE MARKETING STUDY AND PLAN FOR THE CITY AND
6 COUNTY OF SAN FRANCISCO.

7 WHEREAS, The City has invested resources owning and managing seventeen parking
8 garages within the City and County of San Francisco; and,

9 WHEREAS, These garages are an important public resource that promotes commerce
10 in the City's commercial and neighborhood districts by providing parking for residents and
11 visitors; and,

12 WHEREAS, The implementation of an effective marketing plan would assist the
13 Parking Authority in selling currently available parking spaces in these garages; and,

14 WHEREAS, The Uptown Parking Corporation, the Downtown Parking Corporation, and
15 the Ellis and O'Farrell Parking Garage has offered the City a gift of one hundred and forty
16 thousand dollars to fund such a marketing study and plan for the City; now, therefore, be it

17 RESOLVED, That the Board of Supervisors authorizes the Parking Authority to accept
18 a gift of one hundred and forty thousand dollars from the Uptown Parking Corporation, the
19 Downtown Parking Corporation, and the Ellis and O'Farrell Parking Garage; and be it

20 FURTHER RESOLVED, That the Board of Supervisors authorizes the Parking
21 Authority to expend these funds on a garage marketing study and plan for the City and County
22 of San Francisco.


