5 **Deputy Sheriffs and 8306 Senior Deputy Sheriffs against the City and County of San**
6 **Francisco by the payment of \$94,675; the grievance involves an employment dispute**
7 **under the Memorandum of Understanding.**

9 WHEREAS, On October 20, 2021, the San Francisco Deputy Sheriff’s Association
10 (“Union”) filed a grievance (ERD No. 06-22-4158) on behalf of a class of 8504 Deputy
11 Sheriffs, 8304 Deputy Sheriffs and 8306 Senior Deputy Sheriffs under the Memorandum of
12 Understanding (“MOU”) between the Union and the City and County of San Francisco; and

13 WHEREAS, The grievance involves an employment dispute concerning overtime pay
14 and minimum staffing levels; and

15 WHEREAS, The Sheriff’s Department has recommended settlement of the claim by
16 payment of a total of \$94,675 to the members of the class; now, therefore, be it

17 RESOLVED, That the Board of Supervisors hereby authorizes the City Attorney to
18 settle and compromise the grievance by payment of \$94,675 to the class 8504 Deputy
19 Sheriffs, 8304 Deputy Sheriffs and 8306 Senior Deputy Sheriffs per the attached Exhibit A.
