5 **and November 29; and by further canceling all Board and Committee meetings during**
6 **the summer and winter breaks from August 10 through September 2, 2011 and**
7 **December 14 through December 30, 2011.**

9 WHEREAS, The Board of Supervisors (Board) Rules of Order Section 6.2 states the
10 Board shall hold a regular meeting in the Chamber in City Hall each week at 2:00 pm on
11 Tuesday, unless it is a holiday, in which case the meeting shall be canceled; and

12 WHEREAS, The Rules of Order Section 6.2, also states the Board shall not meet
13 during the week after Thanksgiving, nor between December 23 and December 30, inclusive,
14 and the Board does not traditionally meet the week of December 24; and

15 WHEREAS, Similar to other sitting legislative bodies in the United States, the Board
16 has established recess periods during the summer and winter which members of the Board
17 may plan to be away, without missing any Board or Committee meetings or other important
18 public business, and without causing difficulties in achieving a quorum; now, therefore, be it

19 RESOLVED, That the following regular Tuesday Board meetings, following a Monday
20 holiday be canceled: January 18 (Martin Luther King Jr. Day); February 22 (Presidents Day);
21 May 31 (Memorial Day); July 5 (Independence Day); October 11 (Columbus Day); November
22 29 (Week after Thanksgiving); and, be it

23 FURTHER RESOLVED, That pursuant to the established tradition of summer and
24 winter recess periods, the Board and Committee meetings scheduled from August 10 through
25 September 2, 2011, and December 14 through December 30, 2011, are canceled.
