

1 [Administrative, Labor and Employment Codes - Prevailing Wage and Other Labor
2 Requirements]

3 **Ordinance amending the Administrative Code and Labor and Employment Code to**
4 **move certain employment-related provisions, including, among others, certain**
5 **Prevailing Wage requirements, apprenticeship requirements, and hours and days of**
6 **labor requirements, from the Administrative Code to the Labor and Employment Code;**
7 **establish new defined terms encompassing the projects and contracts subject to**
8 **Prevailing Wage requirements; revise penalty and enforcement requirements and**
9 **procedures for Prevailing Wage and certain other labor requirements; change the**
10 **process for fixing and determining Prevailing Wage rates; move and revise the**
11 **Transition Employment requirements and create new enforcement procedures for**
12 **those requirements; apply Notice of Forfeiture/Certification of Forfeiture procedures for**
13 **violations of Prevailing Wage requirements on Covered Real Estate Projects; renumber**
14 **certain Municipal Code sections or provisions; and make other substantive or technical**
15 **amendments to the Administrative Code and Labor and Employment Code, including,**
16 **among others, eliminating certain exemptions from Prevailing Wage requirements for**
17 **Broadcast Services work and the work of loading and unloading Commercial Vehicles**
18 **on City property, while creating an exemption from Prevailing Wage requirements for**
19 **work covered by the Modular Furniture Installers (Carpenters) classification.**

Be it ordained by the People of the City and County of San Francisco:

2 Section 1. Background and Findings.

3 (a) Overview. As of 2024, the City's Municipal Code contained multiple provisions
4 related to the payment of Prevailing Wages, including in Chapters 6 and 23 of the
5 Administrative Code and Article 102 of the Labor and Employment Code. Prevailing Wage
6 requirements have grown in complexity and length, with Chapter 6, Chapter 23, and Article
7 102 each having distinct requirements that differ from one another in significant ways.
8 Locating such provisions across multiple codes, chapters, and articles can make it more
9 difficult for City officials and employees and for the public (including, among others,
10 employees, unions, and businesses) to find and understand the requirements, which is key to
11 ensuring that workers receive legally required wage and fringe benefits. This ordinance moves
12 the Prevailing Wage requirements of Chapters 6 and 23, along with other City labor
13 requirements, to the Labor and Employment Code to consolidate them with the requirements
14 of Article 102, and improve and clarify Prevailing Wage requirements as a whole. In addition,
15 certain Prevailing Wage requirements – for instance, the penalty provisions of Labor and
16 Employment Code Article 102 – benefit from substantive amendments in this ordinance that
17 help to ensure compliance.

18 (b) Reorganization. As noted above, a key feature of this ordinance is to reorganize
19 and consolidate related legal provisions that have been scattered in the Municipal Code. In
20 particular:

21 (1) This ordinance creates Articles 101 and 103 through 109 in the Labor and
22 Employment Code. It moves the Prevailing Wage requirements and Hours and Days of Labor
23 requirements of Chapter 6 of the Administrative Code, and the Prevailing Wage,
24 Apprenticeship, and Local Hire requirements of Chapter 23 of the Administrative Code into the
25 newly created Articles 101 and 103 through 107 of the Labor and Employment Code.

1 (2) The ordinance moves many of the general provisions in Article 102 –
2 including, among others, provisions related to penalties, enforcement, and the keeping of
3 payroll records – out of Article 102 and into new articles addressing those topics.

4 (3) This ordinance consolidates the City's Prevailing Wage requirements, and
5 other labor requirements, and organizes the provisions as follows:

6 (A) Article 101 contains the general provisions for Articles 101 through
7 109, including definitions;

8 (B) Article 102 contains requirements for certain service contracts that are
9 subject to Prevailing Wage requirements;

10 (C) Article 103 includes the requirement to pay the Prevailing Rate of
11 Wages, procedures for the setting of the Prevailing Rate of Wages, and language the City
12 must include in contracts subject to Prevailing Wage requirements;

13 (D) Article 104 contains Apprenticeship requirements for real property
14 sales and leases subject to Prevailing Wage requirements;

15 (E) Article 105 contains Hours and Days of Labor requirements applicable
16 to certain Covered Projects subject to Prevailing Wage requirements;

17 (F) Article 106 contains consolidated penalty and enforcement provisions
18 for violations of the City's Prevailing Wage requirements;

19 (G) Article 107 authorizes the Office of Labor Standards Enforcement
20 ("OLSE") to administer and enforce Prevailing Wage requirements and other labor standards;

21 (H) Article 108 sets forth Local Hire requirements for real property sales
22 and leases subject to Prevailing Wage requirements; and

23 (I) Article 109 contains transition employment requirements for certain
24 City services contracts.
25

1 (c) Technical and Non-Substantive Amendments. The ordinance also makes technical
2 and non-substantive amendments to the text of the Administrative Code and the Labor and
3 Employment Code in order to correctly designate or reference the reorganized provisions.
4 These technical amendments include renumbered provisions and amended citations to reflect
5 the changed and/or relocated text, as well as deleted text that otherwise would be redundant
6 with another consolidated provision.

7 (d) Substantive Amendments. The ordinance makes a number of substantive
8 amendments to the City's Municipal Code. The following list is a summary of such
9 amendments, but it is not a comprehensive list or summary of those changes.

10 (1) Prior to this ordinance, Chapter 6 of the Administrative Code defined "Public
11 Work or Improvement" in multiple ways: Section 6.1 provided a general definition, and Section
12 6.22(e) provided a separate definition solely for the purpose of the Prevailing Wage
13 requirements and certain other labor standards that referenced Section 6.22(e). These
14 multiple definitions created a risk of misunderstanding. To address this problem, this
15 ordinance re-designates the classes of contracts and projects subject to Prevailing Wage
16 requirements into two categories, Covered Contracts and Covered Projects. Covered
17 Contracts is the term Article 102 of the Labor and Employment Code has used to identify
18 service contracts subject to the Prevailing Wage requirements of Article 102. Covered
19 Projects is a new term that encompasses projects that were subject to Prevailing Wage
20 requirements under Chapter 6 or Chapter 23 of the Administrative Code. There are three sub-
21 definitions within the broader definition of Covered Project:

22 (A) Covered Local Project encompasses projects that are subject to
23 Prevailing Wage requirements because they fall within Chapter 6 of the Administrative Code's
24 definition of Public Work or Improvement; they qualify as residential projects required to
25 comply with "City Contracting Requirements" pursuant to Chapter 43, Article IX of the

1 Administrative Code; or they are projects required to pay Prevailing Wages pursuant to the
2 City Loan program in Administrative Code Section 66.13;

3 (B) Covered State Project encompasses projects that are subject to
4 Prevailing Wage requirements as a result of the Municipal Code having incorporated and
5 adopted by reference certain State requirements for Prevailing Wages; this includes the
6 Municipal Code's incorporating for Prevailing Wage purposes the California Labor Code's
7 definition of "public works"; and

8 (C) Covered Real Estate Project encompasses projects subject to
9 Prevailing Wage requirements as a result of the work arising from a City property sale
10 contract or lease.

11 (2) The ordinance creates a new Article 103 of the Labor and Employment
12 Code.

13 (A) Section 103.1 requires that all Contractors and Subcontractors
14 performing work on a Covered Project or a Covered Contract shall pay their workers not less
15 than the Prevailing Rate of Wages. In addition, Section 103.1 clarifies that in situations where
16 the rate required by the Minimum Compensation Ordinance, Labor and Employment Code
17 Article 111, exceeds the Prevailing Rate of Wages, the worker is entitled to the higher rate of
18 the Minimum Compensation Ordinance.

19 (B) Section 103.2 establishes the process by which the Board of
20 Supervisors (the "Board") sets the Prevailing Rate of Wages under the City's Municipal Code.
21 The ordinance sets a deadline of December 31 of each year for the Board to fix and
22 determine the Prevailing Rate of Wages, and provides that if the Board does not do so by the
23 deadline, the Civil Service Commission's recommended rates shall become the Prevailing
24 Rate of Wages. This provision will help keep rates under the Labor and Employment Code
25 reasonably in line with changes in private wage rates. In addition, because the California

1 Department of Industrial Relations generally issues two wage determinations per year for
2 recognized crafts and classifications – one determination taking effect in March, the other
3 taking effect in September – the ordinance endorses and permits the Board to update the
4 Prevailing Rate of Wages to track and match future wage determinations issued by the
5 California Department of Industrial Relations.

6 (C) Section 103.3 contains multiple requirements applicable to Covered
7 Contracts and Covered Projects. The City must generally require inclusion of these
8 requirements in its contracts; however, this ordinance confirms that a failure to do so does not
9 annul the applicability of Prevailing Wage requirements. The ordinance further specifies the
10 documentation related to the payment of wages which a Contractor must maintain and make
11 available for inspection. Covered Projects must submit certified payroll reports to OLSE;
12 however, any Covered Contract that does not also qualify as a Covered Project is exempt
13 from the certified payroll submission requirement, unless required by contract.

14 (3) This ordinance creates Articles 104 and 105 of the Labor and Employment
15 Code. Article 104 contains Apprenticeship requirements applicable to Covered Real Estate
16 Projects, and Article 105 contains Hours and Days of Labor requirements applicable to
17 Covered Local Projects and Covered Real Estate Projects. The ordinance amends the penalty
18 and enforcement provisions that apply to Articles 104 and 105, providing for enforcement
19 under Article 106. In addition, the ordinance amends Hours and Days of Labor requirements
20 to apply expressly to Covered State Projects and places the amended requirements in Article
21 105.

22 (4) This ordinance creates Article 106 of the Labor and Employment Code,
23 which establishes consolidated penalty and enforcement provisions for Prevailing Wage,
24 Apprenticeship, and Hours and Days of Labor requirements. The penalty and enforcement
25 provisions are similar to the provisions that were previously located in Section 6.22(e) of the

1 Administrative Code, with Article 106 providing for OLSE's or the contracting Department
2 Head's enforcement through issuance of a Notice of Forfeiture/Certification of Forfeiture
3 ("NOF/COF") in instances where the City can withhold funds, and OLSE's enforcement
4 through issuing a Determination of Violation ("DOV") where the City cannot withhold funds.

5 A significant substantive amendment of this ordinance in Article 106 is the
6 application of new penalties and enforcement procedures to Covered Contracts. For Covered
7 Contracts, Article 106 provides for expanded and more detailed enforcement and recourse
8 procedures, including the City's issuance of a NOF/COF or DOV for violations, recourse
9 procedures, and additional detail on a party's right to appeal.

10 (5) Under Administrative Code Chapter 23, which required Prevailing Wages on
11 certain projects related to City real estate transactions, Prevailing Wage violations were
12 subject to enforcement through the DOV process. With this ordinance, Covered Real Estate
13 Projects are now, under Section 106.2 of Article 106, subject to enforcement through the
14 NOF/COF process. However, a Covered Real Estate Project is exempt from enforcement
15 under Section 106.2 where the funds available for the City to withhold consist of funds the City
16 has agreed to disburse through a loan.

17 (6) This ordinance also amends Article 102 of the Labor and Employment
18 Code.

19 (A) The ordinance moves the Transition Employment Requirements of
20 Labor and Employment Code Section 102.1(d) to the new Article 109, and provides for OLSE
21 enforcement of the Transition Employment Requirements. The ordinance also enacts new
22 enforcement and resource provisions, incorporating the text of Sections 71.3 and 71.4 of
23 Article 71 of the Labor and Employment Code's Transition Employment Requirements, with
24 the exception of the provision allowing the City Attorney or an employee to bring an action for
25 an injunction against the award authority, which this ordinance omits.

1 (B) This ordinance makes certain other substantive amendments to
2 Article 102, including:

3 (i) For Moving Services contracts as defined under Section
4 102.6, this ordinance creates an exemption for work covered by the California Department of
5 Industrial Relations' Modular Furniture Installers (Carpenters) classification;

6 (ii) For Motor Bus Service contracts as defined under Section
7 102.7, the Purchaser no longer has discretion to omit a contract from coverage where the
8 contract would otherwise meet the requirements of the Section;

9 (iii) For Trade Show and Special Event Work on City property
10 as defined under Section 102.8, this ordinance removes the prior exemption from coverage
11 for "[a]ny permit or agreement to engage in film production pursuant to Chapter 57 of [the
12 Administrative] Code or under the circumstances set forth in Section 57.7 of [that] Code"; and
13 the ordinance clarifies the definition of "Exhibit, Display, or Trade Show Work" to include
14 enclosures, tenting, and furniture;

15 (iv) For Broadcast Services work as defined under Section
16 102.9, this ordinance deletes the exemption for work covered by a collective bargaining
17 agreement; and

18 (v) For loading and unloading of Commercial Vehicles on City
19 property as defined under Section 102.10, this ordinance deletes the prior exemption for work
20 covered by a collective bargaining agreement.

21
22 Section 2. Chapter 6, Article I, of the Administrative Code is hereby amended by
23 revising Section 6.1, to read as follows:
24

1 **SEC. 6.1. DEFINITIONS.**

2 **Advertisement For Bid.** An Advertisement For Bid is a set of documents which
3 includes without limitation the published Advertisement for Bids on a construction Contract;
4 the forms to be submitted with a Bid, as required by the contracting department and CMD; the
5 construction Contract general and special conditions; and the plans and specifications for the
6 Public Work or Improvement.

7 **Award.** The action taken by the City in conformance with the Administrative Code and
8 the Charter to enter into a Contract pursuant to this Chapter 6.

9 (a) For Contracts in excess of the Threshold Amount, a Contract is awarded by the
10 City when the following events have occurred:

11 (1) For departments under the Mayor, ~~(a)~~ the Mayor has approved the Contract
12 for Award; and ~~(b)~~ the Department Head has then issued an order of Award;

13 (2) For departments empowered to contract for Public Works or Improvements
14 with boards or commissions, ~~(a)~~ the Department Head has recommended to the board or
15 commission concerned a Contract for Award; and ~~(b)~~ such board or commission has then
16 adopted a resolution awarding the Contract.

17 (b) For Contracts less than or equal to the Threshold Amount, a Contract is awarded
18 when the Department Head either signs the Contract or issues an order of Award, whichever
19 occurs first. Pursuant to Charter Section 3.105, all Contract Awards are subject to certification
20 by the Controller as to the availability of funds.

21 **Bid.** A sealed document submitted in response to an Advertisement For Bids. No Bid
22 shall be deemed accepted by the City until such time as the Contract is awarded in
23 accordance with this Chapter 6.

24 **Bidder.** One who submits a Bid in response to an Advertisement For Bids.

25 **City.** The City and County of San Francisco.

1 **Construction Manager.** Any individual, firm, partnership, corporation, association, joint
2 venture or other legal entity permitted by law to furnish construction management services to
3 the City.

4 **Contract.** For the purposes of this Chapter, a Contract is an agreement in writing
5 between the City and any party to perform professional design services, consultant services,
6 construction management services or construction services relative to a Public Work or
7 Improvement. No Contract shall be deemed awarded, effective or binding on the City until
8 such time as the requirements for Award are met, as provided in this Chapter 6.

9 **Contract Monitoring Division (“CMD”).** A division of the Office of the City
10 Administrator to which the City Administrator has delegated responsibility to implement
11 Administrative Code Chapter 14B.

12 **Contractor.** A party who contracts directly with the City to perform professional design
13 services, consultant services, construction management services or construction services
14 relevant to a Public Work or Improvement. A Contractor performing construction services may
15 also be referred to as a "General Contractor" or a "Prime Contractor."

16 **Core Trade Subcontractor.** A subcontractor identified by the City or the Contractor
17 that may provide key pre-construction services for a procurement under Section 6.61 or
18 Section 6.68.

19 **Department Head.** The duly appointed General Manager, Director, or Executive
20 Director of a City department authorized to perform Public Work or Improvements under
21 Section 6.2. For purposes of this Chapter 6 only, an authorized Department Head may
22 designate an individual to execute on the Department Head’s behalf any document referenced
23 in this Chapter 6, including but not limited to Contracts, change orders, modifications, service
24 orders, task orders, approvals, progress payments, and certificates of acceptance. Such
25

1 designation shall be in writing and shall identify the individual by name and title and the scope
2 and term of the designation.

3 **Integrated Furniture, Fixtures, and Equipment (“IFF&E”).** Furniture, fixtures, and/or
4 equipment that require integration that significantly affects the building design and/or the
5 design of interior renovation of a Public Work or Improvement due to physical dimension,
6 power connection, or data communication, and/or coordination with construction trades,
7 including but not limited to, electrical, plumbing, mechanical, or building controls.

8 **Mayor.** The Mayor of the City and County of San Francisco or *the* Mayor’s designee,
9 provided that the designee is not the Department Head of the department concerned in the
10 particular matter that the Mayor is responsible for reviewing.

11 ~~*—Prevailing Wage or Prevailing Rate of Wage. For purposes of this Chapter 6, the highest*~~
12 ~~*general prevailing rate of wage plus "per diem wages" and wages paid for overtime and holiday work*~~
13 ~~*paid in private employment in the City for the various crafts and kinds of labor employed in the*~~
14 ~~*performance of any Public Work or Improvement. "Per diem wages" are defined pursuant to Labor*~~
15 ~~*Code Section 1773.1, as amended from time to time.*~~

16 **Public Work or Improvement.** Any erection, construction, renovation, alteration,
17 improvement, demolition, excavation, installation, or repair of any public building, structure,
18 infrastructure, bridge, road, street, park, dam, tunnel, utility, or similar public facility performed
19 by or for the City, the cost of which is to be paid wholly or partially out of moneys deposited in
20 the Treasury of the City. A Public Work or Improvement may include *IFF&E Integrated*
21 ~~*Furniture, Fixtures, and Equipment.*~~

22 **Quote or Quotation.** A statement or proposal setting out the estimated cost for work or
23 services submitted in response to a request for a quote from a department for work or
24 services on a Public Work or Improvement.

1 **Responsible or Responsibility.** A Bidder General Contractor, or Prime Contractor for
2 a Public Work or Improvement, that:

3 (a) meets the qualifying criteria required for a particular project, including without
4 limitation the expertise, experience, record of prior timely performance, license, resources,
5 and bonding and insurance capability necessary to perform the work under the Contract; and

6 (b) at all times deals in good faith with the City and submits bids, estimates,
7 invoices, claims, requests for equitable adjustments, requests for change orders, requests for
8 Contract modifications, or requests of any kind seeking compensation on a City Contract only
9 upon a good faith honest evaluation of the underlying circumstances and a good faith, honest
10 calculation of the amount sought; and

11 (c) substantiates its record of safe performance on construction projects, including
12 but not limited to consideration of federal or state Occupational Safety and Health
13 Administration (“OSHA”) violations and work place fatalities, including OSHA citations under
14 appeal, in accordance with regulations issued by the City Administrator.

15 **Responsive.** A Bid or proposal that complies with the requirements of the subject
16 Advertisement For Bids or request for proposals and/or qualification without condition or
17 qualification.

18 **Threshold Amount.** The Threshold Amount, for the purposes of this Chapter 6, is
19 \$1,000,000. For every five-year period starting with January 1, 2020-December 31, 2024, the
20 Controller shall recalculate the Threshold Amount to reflect any proportional increase in the
21 Urban Regional Consumer Price Index from January 1, 2020, rounded to the nearest \$10,000.
22 The Threshold Amount as recalculated by the Controller shall take effect by operation of law
23 on January 1 of the first year of the next five-year period (thus, for example, on January 1,
24 2025 following the five-year period ending December 31, 2024).

1 Section 3. Chapter 6, Article II, of the Administrative Code is hereby amended by
2 revising Section 6.22, to read as follows:

3 **SEC. 6.22. PUBLIC WORK CONSTRUCTION CONTRACT TERMS AND WORKING**
4 **CONDITIONS.**

5 All construction Contracts awarded under this Chapter 6 by the City shall contain the
6 following minimum terms and conditions:

7 * * * *

8 **(e) Prevailing Wages.**

9 ~~—————(1) **Generally.** All Contractors and subcontractors performing a Public Work or~~
10 ~~Improvement for the City shall comply with the requirements of Articles 101 through 107 of the~~
11 ~~Labor and Employment Code, as applicable. pay its workers on such projects the Prevailing Rate of~~
12 ~~Wages as provided below. For the purpose of Prevailing Wage requirements only, the definition of a~~
13 ~~public work shall include Public Works or Improvements as defined in the Section 6.1, and shall also~~
14 ~~include (A) any trade work performed at any stage of construction (including preconstruction work)~~
15 ~~and (B) any public work paid for by the City with "the equivalent of money" under the meaning of~~
16 ~~California Labor Code Section 1720(b).~~

17 ~~—————(2) **Additional Projects Considered as "Public Works or Improvements" for Purposes of**~~
18 ~~**Prevailing Wages.**~~

19 ~~—————(A) **Property Leased or Sold by the City.** For construction work performed on real~~
20 ~~property leased by the City or sold by the City for Housing Development, as that term is defined in~~
21 ~~Administrative Code subsection 23.61(a), Contractors and subcontractors must pay prevailing wages~~
22 ~~in accordance with Article VII of Chapter 23 of the Administrative Code and this subsection 6.22(e) as~~
23 ~~applicable.~~

24 ~~—————(B) **Public Works Under California Labor Code.** For the limited purposes of this~~
25 ~~subsection 6.22(e) and Section 6.24, a "public work or improvement" also means and includes all~~

1 ~~projects for "public works" as defined in California Labor Code Section 1720, and projects for which~~
2 ~~Prevailing Wages are required to be paid pursuant to California Labor Code Section 1782. This~~
3 ~~subsection 6.22(e)(2)(B) is intended to have prospective effect only, and shall not be interpreted to~~
4 ~~impair the obligations of any pre-existing grant agreement, lease, development agreement or other~~
5 ~~contract entered into by the City. Notwithstanding the prior sentence, this subsection shall apply to~~
6 ~~newly included work in pre-existing grant agreements, leases, development agreements, or other~~
7 ~~contracts amended on or after the operative date. The subsection shall apply to grant agreements,~~
8 ~~leases, development agreements and other contracts entered into by the City on or after the operative~~
9 ~~date. All grant agreements, leases, development agreements and other contracts which allow for such~~
10 ~~construction on property owned by the City that the City enters after the operative date of the~~
11 ~~subsection must contain a provision that such construction shall comply with this subsection.~~

12 ~~— (3) **Determination of the Prevailing Wage.** It shall be the duty of the Board of Supervisors,~~
13 ~~from time to time and at least once during each calendar year, to fix and determine the Prevailing Rate~~
14 ~~of Wages as follows:~~

15 ~~— On or before the first Monday in November of each year, the Civil Service Commission~~
16 ~~shall furnish to the Board of Supervisors data as to the highest general Prevailing Rate of Wages of the~~
17 ~~various crafts and kinds of labor as paid in private employment in the City and County of San~~
18 ~~Francisco, plus "per diem wages" and wages for overtime and holiday work. The Civil Service~~
19 ~~Commission shall provide the Board of Supervisors data for "per diem wages" pursuant to California~~
20 ~~Labor Code Sections 1773.1 and 1773.9, as amended from time to time. The Board of Supervisors~~
21 ~~shall, upon receipt of such data, fix and determine the Prevailing Rate of Wages. The Prevailing Rate~~
22 ~~of Wages as so fixed and determined by the Board of Supervisors shall remain in force and shall be~~
23 ~~deemed to be the highest general Prevailing Rate of Wages paid in private employment for similar~~
24 ~~work, until the same is changed by the Board of Supervisors. In determining the highest general~~
25 ~~Prevailing Rate of Wages per diem wages and wages for overtime and holiday work, as provided for in~~

1 *this section, the Board of Supervisors shall not be limited to the consideration of data furnished by the*
2 *Civil Service Commission, but may consider such other evidence upon the subject as the Board shall*
3 *deem proper and thereupon base its determination upon any or all of the data or evidence considered.*

4 *— In the event that the Board of Supervisors does not fix or determine the highest general*
5 *Prevailing Rate of Wages in any calendar year, the rates established by the California Department of*
6 *Industrial Relations for such year shall be deemed adopted.*

7 *— (4) **Specifications to Include Wage Rate.** The Department Head shall include in the*
8 *contract specifications, or make available in the offices of the department or at the job site, a detailed*
9 *statement of the Prevailing Rate of Wages as fixed and determined by the Board of Supervisors at the*
10 *time the department issued the Advertisement For Bids on the contract. The Contractor shall agree to*

22 work is to be performed, shall prevail over the requirements of this Article VII when such laws,
23 rules or regulations are in conflict.

24 (A) all construction projects on real property owned by the City; and

1 (B) all construction projects on City-owned real property located within

15 Contractors and Subcontractors in complying with the Policy, and to assist OEWD in
16 furthering the purposes of the Policy through monitoring and enforcement activities. OEWD

6 **SEC. 101.1. GENERAL DEFINITIONS.**

7 For the purposes of Articles 101 through 109, the following definitions apply.

8 **Apprentice.** Any worker who is indentured in a construction apprenticeship program that
9 maintains current registration with the State of California's Division of Apprenticeship Standards.

10 **City.** The City and County of San Francisco.

11 **Contractor.** Any person, firm, partnership, owner operator, limited liability company,
12 corporation, joint venture, proprietorship, trust, association, or other entity that directly enters into an
13 agreement, including, without limitation, any contract, franchise, lease, or permit, for a Covered
14 Contract or Covered Project. A Contractor may also be referred to as a "Prime Contractor" or
15 "General Contractor."

16 **Contracting Officer.** Any officer or employee of the City authorized to enter into a Covered
17 Contract on behalf of the City.

18 **Covered Contract.** Covered Contract shall mean an agreement, including, without limitation,
19 any contract, franchise, lease, or permit, between the City and a Contractor for the following services:
20 "Janitorial Services" as defined in Section 102.2; "Public Off-Street Parking Lots, Garages, or
21 Storage Facilities for Automobiles" as defined in Section 102.3; "Theatrical Services" as defined in
22 Section 102.4; "Hauling of Solid Waste Generated By The City In Course of City Operations" as
23 defined in Section 102.5; "Moving Services" as defined in Section 102.6; "Motor Bus Services" as
24 defined in Section 102.7, subject to the provisions of Section 102.7; "Trade Show and Special Event
25 Work" as defined in Section 102.8; "Broadcast Services" as defined in Section 102.9; "Loading,

1 Unloading, and Driving of Commercial Vehicles” as defined in Section 102.10; or “Security Guard
2 Services” as defined in Section 102.11.

3 **Covered Project.** “Covered Project” shall mean a project satisfying one or more of the
4 following definitions:

5 **“Covered Local Project.”** Any Public Work or Improvement as defined in Section 6.1 of
6 the Administrative Code; any residential project required to comply with “City Contracting
7 Requirements” pursuant to Chapter 43, Article IX of the Administrative Code; and/or any project
8 required to pay prevailing wages pursuant to Administrative Code Section 66.13.

9 **“Covered State Project.”** Any “public works” as defined in California Labor Code
10 Section 1720; any project for which Prevailing Wages are required to be paid pursuant to California
11 Labor Code Section 1782; and/or any project subject to prevailing wage requirements under State law,
12 including, but not limited to, California Government Code Section 65913.4(a)(8)(A)(ii), where the City,
13 through its discretion or not, approves or permits plans, specification, or criteria for the project, and
14 State law does not bar City enforcement of the prevailing wage requirements.

15 **“Covered Real Estate Project.”** Any project for any erection, construction, renovation,
16 alteration, improvement, demolition, excavation, installation, or repair, including tenant improvements,
17 that meets the following requirements: (1) the real property on which the project is located is within the
18 jurisdictional boundaries of the City; (2) the estimated project cost exceeds the Threshold Amount; and
19 (3) the project is performed, in whole or in part, on (A) any real property sold to the Real Property
20 Contracting Party under a City-as-seller contract for Housing Development; or (B) real property
21 leased by the City as a landlord or leased to the City as a tenant, where the construction is performed
22 before or during the term of the lease in accordance with plans, specifications, or criteria approved by
23 the City.

24 The scope of the Covered Project shall include any trade work performed at any stage of
25 construction, including, without limitation, preconstruction work.

1 **Department Head.** *The term as defined under Section 6.1 of the Administrative Code; or the*
2 *Purchaser or any other officer authorized to award a Services contract under Chapter 21 of the*
3 *Administrative Code.*

4 **Housing Development.** *Any residential or mixed-use project that includes the construction,*
5 *expansion, or rehabilitation of three or more residential units.*

6 **Labor Standards Enforcement Officer.** *Labor Standards Enforcement Officer shall have the*
7 *meaning established in Section 2A.23(b) of the Administrative Code.*

8 **Prevailing Wage or Prevailing Rate of Wages.** *The highest general prevailing rate of wages*
9 *plus “per diem wages” and wages paid for overtime and holiday work paid in private employment for*
10 *similar work for the various crafts and kinds of labor employed in the performance of any Covered*
11 *Project or Covered Contract. “Per diem wages” are defined pursuant to California Labor Code*
12 *Section 1773.1, as amended from time to time, which includes benefits, as defined therein.*

13 **Prevailing Wage Provisions.** *“Prevailing Wage Provisions” refers collectively to Articles 101*
14 *through 107. Certain of these provisions include subjects other than Prevailing Wage, such as*
15 *apprenticeship requirements in Article 104 and the hours and days of labor requirements in Article*
16 *105.*

17 **Real Property Contracting Party.** *Any entity or individual, or successor in interest to the rights*
18 *of any entity or individual, who is: (1) the buyer of real property intended for Housing Development*
19 *under a City-as-seller contract, (2) the landlord under a City-as-tenant lease, or (3) the tenant under a*
20 *City-as-landlord lease; provided, however, that a public entity shall not be considered a Real Property*
21 *Contracting Party.*

22 **Subcontractor.** *Any person, firm, partnership, owner operator, limited liability company,*
23 *corporation, joint venture, proprietorship, trust, association, or other entity that contracts with a*
24 *Contractor or a Subcontractor to provide work on a Covered Contract or Covered Project.*
25

1 **Threshold Amount.** The Threshold Amount as defined in Section 6.1 of the Administrative
2 Code.

3
4 **SEC. 101.2. NO CAUSE OF ACTION AGAINST THE CITY.**

5 In no event shall any person or entity have the right to bring an action against the City based on
6 any alleged failure to enforce or negligent enforcement of the requirements of Articles 101 through
7 109.

8
9 **SEC. 101.3. PREEMPTION.**

10 For any contract that receives funds furnished, given, or loaned by the Government of the
11 United States or the State of California, any requirement of Articles 101 through 109 that conflicts with
12 a requirement of the funding source shall not apply to the contract. Nothing in Articles 101 through
13 109 shall be interpreted or applied so as to create any power or duty in conflict with any federal law.
14 Nothing in Articles 101 through 109 shall be interpreted or applied so as to create any power or duty in
15 conflict with any State law, except to the extent the City's home rule powers govern. For the purposes
16 of this Section 101.3, a conflict does not exist where the federal law or State law does not prohibit
17 standards exceeding those set by the federal law or State law.

18
19 **SEC. 101.4. SEVERABILITY.**

20 If any part or provision, including a section, subsection, sentence, or word, of Articles 101
21 through 109 or the application thereof to any person or circumstance, is held invalid, the remainder of
22 Articles 101 through 109, including the application of such part or provisions to other persons or
23 circumstances, shall not be affected thereby and shall continue in full force and effect. To this end, the
24 provisions of Articles 101 through 109 are severable.

1 Section 8. Article 102 of the Labor and Employment Code is hereby amended by
2 revising Sections 102.1 through 102.11, to read as follows:

3 **SEC. 102.1. STANDARD PROVISIONS GOVERNING THE PREVAILING RATE OF**
4 **WAGES FOR SERVICES CONTRACTS, WORKER RETENTION, AND USE OF EMPLOYEES**

11 (b) **Definitions.** For purposes of this Article 102, the following definitions shall apply
12 to the terms used herein.

14 ~~“Contracting Officer” shall mean any officer or employee of the City authorized to enter into a~~
15 ~~Covered Contract on behalf of the City.~~

16 ~~“Contractor” shall mean any Person who submits a bid or proposal and/or enters into a Covered~~
17 ~~Contract.~~

18 ~~“Covered Contract” shall mean an agreement between the City and a Contractor for the following~~
19 ~~services: “Motor Bus Services” as defined in Section 102.7, subject to the provisions of Section 102.7;~~
20 ~~“Janitorial Services” as defined in Section 102.2; “Public Off-Street Parking Lots, Garages, or~~

3 “Individual” shall mean any person who performs work under a Covered Contract.

4 ~~“Permit” shall mean a permit to use City property, and shall include a permit to use a public right~~
5 ~~of way, including a street or sidewalk encroachment permit or closure permit, including but not limited~~
6 ~~to an ISCOTT (Interdepartmental Staff Committee on Traffic and Transportation) permit.~~

7 “Person” shall mean any individual, proprietorship, partnership, joint venture,
8 corporation, limited liability company, trust, association, or other entity that may employ or hire
9 individuals or enter into contracts.

10 ~~“Prevailing Rate of Wages” shall mean that rate of compensation, including fringe benefits or the~~
11 ~~matching equivalents thereof, being paid to a majority of workers engaged in the services for which a~~
12 ~~Covered Contract is entered into by the City and County of San Francisco, if a majority of such~~
13 ~~workers are paid at a single rate; if there is no single rate being paid to a majority, then the prevailing~~
14 ~~rate shall be that single rate being paid to the greatest number of workers.~~

15 ~~“Subcontract” shall mean any agreement under or subordinate to a prime Contract.~~

16 ~~“Subcontractor” shall mean any Person who enters into a Subcontract with a Contractor.~~

17 ~~(c) Prevailing Wage Rate Requirements.~~

18 ~~(1) Determination of Prevailing Rate of Wages. It shall be the duty of the Board of Supervisors,~~
19 ~~from time to time and at least once during each calendar year, to fix and determine the Prevailing Rate~~
20 ~~of Wages paid in private employment in the City for Individuals engaged in services under Covered~~
21 ~~Contracts including such rate of wages paid for overtime and holiday work, which said Prevailing Rate~~
22 ~~of Wages shall be fixed and determined as follows:~~

23 ~~— The Civil Service Commission shall furnish to the Board of Supervisors on or before the first~~
24 ~~Monday in November of each year, data as to the Prevailing Rate of Wages for Individuals engaged in~~
25 ~~services under Covered Contracts including such rate of wages paid for overtime and holiday work,~~

1 ~~and the Board of Supervisors shall, upon receipt of such data, fix and determine the Prevailing Rate of~~

3 ~~Rate of Wages as so fixed and determined by the Board of Supervisors shall remain in force and shall~~

6 ~~———— In determining the Prevailing Rate of Wages, as provided for in this Section, the Board of~~
7 ~~Supervisors shall not be limited to the consideration of data furnished by the Civil Service Commission,~~
8 ~~but may consider such other evidence upon the subject as the Board of Supervisors shall deem proper~~
9 ~~and thereupon base its determination upon any or all of the data or evidence considered.~~

10 ~~———— For purposes of this Section, the Civil Service Commission shall provide data on and the Board~~
11 ~~shall certify two components for each craft, classification, and type of work, which together shall be~~
12 ~~deemed the “Prevailing Rate of Wages”: (1) the basic hourly wage rate and (2) the hourly rate of each~~
13 ~~fringe benefit, which together equal the hourly prevailing rate of wages. The Civil Service Commission~~
14 ~~shall provide this data to the Board of Supervisors within days of the effective date of this Section.~~

15 ~~(2)(c) **Contracting Officers.** Each bid or proposal for a Covered Contract shall include,~~
16 ~~on a form provided by the Contracting Officer, the following: (a) the basic hourly rate of wages~~
17 ~~to be paid by the Contractor and Subcontractor, if any, for each craft, classification, or type of~~
18 ~~work to be performed by eEmployees under the Covered Contract; and (b) for each required~~
19 ~~fringe benefit, the hourly cost of each fringe benefit, or cash equivalent, the Contractor and~~
20 ~~Subcontractor, if any, intend to provide. In meeting the Prevailing Rate of Wages, no amount~~
21 ~~of fringe benefit credit shall be used to reduce the obligation to pay the basic hourly straight~~

2 ~~to this Section shall include a provision in which the Contractor agrees to comply with, and to require~~
3 ~~Subcontractors to comply with, the prevailing wage rate requirement imposed by this Section.~~

4 ~~— (4) Enforcement of Prevailing Wage Rate Requirements. Where the Contracting Officer or the~~
5 ~~Labor Standards Enforcement Officer determines that a Contractor or a Subcontractor may have~~
6 ~~violated the prevailing wage rate requirements of this Section, the Contracting Officer or Labor~~
7 ~~Standards Enforcement Officer shall send written notice to the Contractor of the possible violation (a~~

4 ~~jeopardizes the quality, efficiency, and cost-effectiveness of service provided to the City under the~~
5 ~~successor Contract. All Covered Contracts shall impose the following obligations on the Contractor~~
6 ~~and Subcontractor.~~

7 ~~—(1) Where the Contracting Officer has given notice that a Covered Contract will be bid, or where~~
8 ~~a Contractor has given notice of termination, upon giving or receiving such notice, as the case may be,~~
9 ~~the Contractor ("ending Contractor") shall, within ten days thereafter, provide to the Contracting~~

6 ~~—(4) During such six-month period the successor Contractor (or Subcontractor, where applicable)~~

8 ~~Contractor (or Subcontractor) from which the successor Contractor (or Subcontractor) shall hire~~
9 ~~additional Employees.~~

10 ~~—(5) During the six-month period, the successor Contractor (or Subcontractor, where applicable)~~
11 ~~shall not discharge without cause an Employee retained pursuant to this Subsection. “Cause,” for this~~
12 ~~purpose, shall include, but not be limited to, the Employee’s conduct while in the employ of the ending~~
13 ~~Contractor or Subcontractor that contributed to any decision to terminate the Contract or Subcontract~~

15 ~~—(6) At the end of the six-month period, a successor Contractor (or Subcontractor, where~~

5 **(de) Requirement of Employer-Employee Relationship.**

6 (1) The City has an important proprietary interest in maintaining the stability
7 of the workforce engaged by a Contractor for a Covered Contract by ensuring that individuals
8 working pursuant to City contracts have the protections afforded by ~~s~~State and municipal laws
9 governing employment. In order for the City to maintain the integrity of its contracting process,
10 the ~~e~~City's ~~p~~Prevailing ~~w~~Wage laws ensure contractors a level playing field on which to bid for
11 contracts. When contractors are allowed to classify workers as independent owner operators,
12 contractors can appear to pay the ~~p~~Prevailing ~~w~~Wage when in reality, after the owner
13 operator's operating costs are taken into account, the owner operator receives less than the
14 ~~p~~Prevailing ~~w~~Wage for the owner operator's ~~his or her~~ labor. This outcome contradicts one of the
15 goals of the ~~p~~Prevailing ~~w~~Wage law, which is to provide for fair competition among contractors,
16 all of whom must pay workers, at a minimum, the same ~~p~~Prevailing ~~r~~Rate of ~~w~~Wages and
17 benefits. The City's proprietary interest is such that employment of Employees in an
18 Employer-Employee relationship shall be required for all work done under any Covered
19 Contract.

20 (2) Every Covered Contract shall require the Contractor (and Subcontractors,
21 if any) to perform said Covered Contract, with Individuals employed by said Contractor or
22 Subcontractor in an Employer-Employee relationship as defined by California law.

23 (3) No Covered Contract shall be awarded by the City to a Contractor and/or
24 Subcontractor who proposes to perform the Covered Contract with self-employed persons or
25 independent contractors.

1 (4) If during the term of a Covered Contract, a Contractor (or Subcontractor
2 engaged by said Contractor) engages any self-employed persons or independent contractors
3 to perform the Contract for a period of three ~~(3)~~ days or more, the Contractor or Subcontractor
4 shall be subject to the enforcement remedies as set forth in Subsection (e)(4), Article 106,
5 including termination of the Covered Contract or Subcontracts subcontract under Section 106.4, and
6 penalties ~~for willful violation.~~

7 (5) Contractors shall be fully responsible for the compliance of
8 Subcontractors with this ~~provision~~ subsection (d). Contractors shall be jointly and severally liable
9 for any penalties assessed against their Subcontractors in the event that the Subcontractor is
10 unable or unwilling to pay a penalty.

11 (ef) **Preemption.** Nothing in this Section 102.1 shall be interpreted or applied so as
12 to create any power or duty in conflict with any federal or ~~s~~State law.

13 (fg) **No Cause of Action Against City.** This Section 102.1 is not intended to create
14 a private right of action against the City.

15 (gh) **Prospective Application.** This Section 102.1 is intended to have prospective
16 effect only, and shall not be interpreted to impair the obligations of any pre-existing Contract

13 any property owned or leased by the City be paid not less than the Prevailing Rate of Wages,
14 ~~including fringe benefits or the matching equivalents thereof, paid in private employment for similar~~
15 ~~work in the area in which the Contract is being performed.~~ All Contracts subject to this Section
16 102.11 shall include a provision in which the Contractor agrees to comply with, and to require
17 Subcontractors to comply with, the obligations imposed by this Section.

18 (2) **Exclusions.** For purposes of this subsection (b), "Contract" shall mean an
19 agreement to be performed at the expense of the City or to be paid out of moneys deposited
20 in the City treasury or out of trust moneys under the control of or collected by the City, but
21 shall not include the following:

7 **SEC. 103.1. GENERAL REQUIREMENT.**

8 *All Contractors and Subcontractors performing work on a Covered Project or a Covered*
9 *Contract as defined in Article 101 shall pay their workers on such project or contract not less than the*
10 *Prevailing Rate of Wages as set under Section 103.2, or the rate required by the Minimum*
11 *Compensation Ordinance, Labor and Employment Code Article 111, whichever is higher.*

13 **SEC. 103.2. DETERMINATION OF THE PREVAILING WAGE.**

14 *It shall be the duty of the Board of Supervisors ("the Board"), from time to time and at least*
15 *once during each calendar year, to fix and determine the Prevailing Rate of Wages as follows:*

16 *(a) On or before the first Monday in November of each year, the Civil Service Commission*
17 *("the Commission") shall furnish to the Board data as to the highest general Prevailing Rate of Wages*
18 *of the various crafts and kinds of labor as paid in private employment in the City, plus "per diem*
19 *wages" and wages for overtime and holiday work. "Per diem wages" means "per diem wages" as*
20 *defined in California Labor Code Sections 1773.1 and 1773.9, as amended from time to time. Based on*
21 *the data, the Commission shall also recommend to the Board rates for the Prevailing Rate of Wages.*

22 *(b) The Board of Supervisors shall, upon receipt of such data, fix and determine the Prevailing*
23 *Rate of Wages no later than December 31 of that year. If the Board does not fix and determine the*
24 *Prevailing Rate of Wages by December 31, the Commission's recommended rates shall become the*
25 *effective Prevailing Rate of Wages for the coming calendar year.*

1 (c) The Prevailing Rate of Wages as so fixed and determined by the Board (or as described
2 above set by the Commission in the absence of Board action by December 31) shall remain in force and
3 be deemed to be the highest general Prevailing Rate of Wages paid in private employment for similar
4 work, until the same is changed for that calendar year by the Board.

5 (d) Unless the Board expressly states otherwise, the Prevailing Rate of Wages as set by the
6 Board (or as described above set by the Commission in the absence of Board action by December 31)
7 shall track and match future wage determinations issued by the California Department of Industrial
8 Relations.

9 (e) In determining the highest general Prevailing Rate of Wages, as provided for in this Section
10 103.2, the Board shall not be limited to the consideration of data furnished by the Commission, but may
11 consider such other evidence upon the subject as the Board shall deem proper and thereupon base its
12 determination upon any or all of the data or evidence considered.

13 (f) In the event that the highest general Prevailing Rate of Wages are not fixed and determined
14 under this Section 103.2 for any calendar year, the rates established by the California Department of
15 Industrial Relations for such year shall be deemed adopted; and if the Department of Industrial
16 Relations does not so establish a rate for a craft or kind of labor, the most recent rate set under Section
17 103.2 for that craft or kind of labor shall remain in effect.

19 **SEC. 103.3. ADDITIONAL REQUIREMENTS AND CONTRACTUAL PROVISIONS.**

20 (a) **Contractual Prevailing Wage Requirements.** The City shall include in each contract,
21 lease, or any other type of agreement that includes or contemplates a Covered Project or Covered
22 Contract, the requirement that Contractors and Subcontractors performing work on the Covered
23 Project or Covered Contract pay Prevailing Wages in accordance with the requirements of this Article
24 103. The failure of the City to comply with this subsection (a) shall not void or annul the requirements
25 imposed by this Article 103 on Contractors and Subcontractors.

1 **(b) Subcontractors Bound by Wage Provisions.** Every contract, lease, or any other type of
2 agreement that includes or contemplates a Covered Project or Covered Contract shall contain a
3 provision requiring the Contractor and/or any Subcontractor to insert in every subcontract, sublease,
4 or any other arrangement the requirement that the Subcontractor shall pay to all persons performing
5 labor or work for a Covered Project, or rendering service for a Covered Contract, the highest general
6 Prevailing Rate of Wages as fixed and determined in accordance with Section 103.2. This requirement
7 shall apply to any subcontract, sublease, or other arrangement that the Contractor or Subcontractor
8 may make for the performance of any work or labor for a Covered Project, or services for a Covered
9 Contract. The failure of a Contractor or Subcontractor to comply with this subsection (b) shall not void
10 or annul the requirement that any work or labor performed under any subcontract, sublease, or other
11 arrangement made by the Contractor or Subcontractor for work or labor for a Covered Project or
12 services for a Covered Contract must be paid at the highest general Prevailing Rate of Wages as fixed
13 and determined in accordance with Section 103.2.

14 **(c) Additional Required Contract Provisions.** Every contract, lease, or any other type of
15 agreement for a Covered Project or Covered Contract shall contain provisions stating the following:

16 (1) the Contractor will cooperate fully with the Labor Standards Enforcement Officer
17 and other City employees and agents authorized to assist in the administration and enforcement of the
18 Prevailing Wage requirements and other labor standards imposed on the Contractor by the Charter or
19 the Municipal Code;

20 (2) the Contractor agrees that the Labor Standards Enforcement Officer, and the
21 Officer's designees, in the performance of their duties, shall have the right to engage in random
22 inspections of job sites and to have access to the employees of the Contractor, employee time sheets,
23 inspection logs, Contractor daily logs, payroll records, employee paychecks, employee paystubs, and
24 proof of payment documents;

1 (3) the Contractor shall maintain a record in the format prescribed by OLSE of sign-in
2 and sign-out showing which employees have been present on the job site;

3 (4) the Contractor shall prominently post at each job site a sign informing employees
4 that the project is subject to the City's Prevailing Wage requirements and that these requirements are
5 enforced by the Labor Standards Enforcement Officer; and

6 (5) the Labor Standards Enforcement Officer may audit such records of the Contractor
7 or Subcontractor as the Labor Standards Enforcement Officer reasonably deems necessary to
8 determine compliance with the Prevailing Wage and other labor standards imposed by the Charter or
9 the Municipal Code.

10 Failure to comply with any of these requirements may result in penalties and forfeitures
11 consistent with analogous provisions of the California Labor Code, including Section 1776(h), as
12 amended from time to time.

13 (d) **Contract Documents to Include Wage Rate.** The Department Head shall include in the
14 contract specifications or other contract document, or make available in the offices of the department
15 or at the job site, a detailed statement of the Prevailing Rate of Wages as fixed and determined in
16 accordance with Section 103.2 as of the time the department issued the Advertisement For Bids or
17 Solicitation on the contract. The Contractor shall agree to pay to all persons performing covered work
18 or labor on or for the Covered Project or Covered Contract the highest general Prevailing Rate of
19 Wages as determined in accordance with Section 103.2. If the contract documents do not include the
20 Prevailing Rate of Wages, the specifications or contract documents shall include a statement that
21 copies of the Prevailing Rate of Wages as fixed and determined in accordance with Section 103.2 are
22 on file at the department's principal office or at the job site and shall be made available to any
23 interested party on request.

1 **(e) Records.**

2 **(1) Records to be Kept by Contractors and Subcontractors.** *In every instance where*
3 *the Municipal Code or a contractual arrangement – including, without limitation, any agreement,*
4 *contract, franchise, lease, or permit – with the City requires a Contractor or Subcontractor to pay*
5 *Prevailing Wages, the subject contract or subcontract shall contain a provision that the contractor or*
6 *subcontractor shall keep, or cause to be kept, for a period of four years from the date of completion of*
7 *the subject work, payrolls and basic records including time cards, trust fund reports, apprenticeship*
8 *agreements, accounting ledgers, tax forms, proof of payment, and superintendent and foreperson daily*
9 *logs for all trades workers performing work. For purposes of this subsection (e)(1), “completion of the*
10 *subject work” means substantial completion for Covered Projects and the last day of covered work for*
11 *Covered Contracts. Such records shall include the name, address, and social security number of each*
12 *worker who worked on the project or under the contract, including apprentices, worker classification, a*
13 *general description of the work each worker performed each day, the rate of pay (including rates of*
14 *contributions for, or costs assumed, to provide fringe benefits), daily and weekly number of hours*
15 *worked, deductions made, and actual wages paid. Every Subcontractor who shall undertake the*
16 *performance of any part of a project or contractual arrangement subject to this Article 103 shall keep a*
17 *like record of each person engaged in the execution of the subcontract.*

18 **(2) Maintenance and Submission of Certified Payroll Records.**

19 **(A) Each Contractor and Subcontractor subject to this Article 103 shall maintain**
20 *weekly certified payroll records, and shall submit those certified payroll records to the City using the*
21 *Office of Labor Standards Enforcement’s certified payroll reporting system. The awarding department*
22 *may provide by contract for additional payroll maintenance or payroll submission requirements. All*
23 *certified payroll records shall be accompanied by a statement of compliance signed by the Contractor*
24 *or Subcontractor indicating that the payroll records are correct and complete, that the wage rates*
25

1 contained therein are not less than those determined in accordance with Section 103.2, and that the
2 classifications set forth for each employee conform with the work performed.

3 (B) **Exemption.** Unless otherwise provided by contract, Covered Contracts that
4 do not qualify as a Covered Project are exempt from the requirement that the Contractor submit
5 certified payroll records to the City.

6 (3) All such records as described in this subsection (e) shall at all times be open to
7 inspection and examination of the duly authorized officers and agents of the City, including
8 representatives of the Office of Labor Standards Enforcement.

9 (4) Should the Department Head or the Labor Standards Enforcement Officer determine
10 that a Contractor or Subcontractor is not in compliance with the requirements of this subsection (e),
11 the Department Head or the Labor Standards Enforcement Officer shall issue written notification to the
12 Contractor or Subcontractor mandating compliance within not fewer than 10 calendar days from the
13 date of the notification. Should the Contractor or Subcontractor fail to comply as required in the
14 notification, the Department Head who executed the contract or the Labor Standards Enforcement
15 Officer may impose penalties consistent with analogous provisions of the California Labor Code,
16 including Section 1776, as amended from time to time, for each calendar day of noncompliance, or
17 portion thereof, for each worker. Upon the request of the responsible Department Head or the Labor
18 Standards Enforcement Officer, the Controller shall withhold these penalties from progress payments
19 then due or to become due.

20 (f) **City as Third Party Beneficiary.** The City shall in each contract, lease, or any other
21 type of agreement that includes or contemplates work qualifying as a Covered Real Estate Project: (1)
22 a provision naming the City, affected workers, and employee organizations formally representing
23 affected workers, as third party beneficiaries for the limited purpose of having the right to enforce the
24 Prevailing Wage requirements of Article 103 and apprenticeship requirements of Article 104, including
25 the right to file charges and seek penalties against any Contractor or Subcontractor in accordance with

1 Articles 103 through 106 and (2) a provision requiring the Real Property Contracting Party to
2 reasonably cooperate with the City in any action or proceeding against a Contractor or Subcontractor
3 that fails to pay the Prevailing Rate of Wages or employ Apprentices as required. A Real Property
4 Contracting Party that requires the payment of Prevailing Wages and employment of Apprentices in the
5 Covered Project, and that reasonably cooperates with the City in any enforcement action, shall not be
6 in breach of the applicable sales contract or lease with the City due to a Contractor's or
7 Subcontractor's failure to pay the Prevailing Rate of Wages or employ Apprentices. So long as the Real
8 Property Contracting Party satisfies the requirements of the previous sentence, and has not directly
9 performed trade work on the Covered Project, any enforcement action by the City, through the City's
10 Labor Standards Enforcement Officer or otherwise, shall be directly against the Contractor or
11 Subcontractor that failed to pay Prevailing Wages or employ Apprentices as required. Nothing in this
12 Article 103 shall limit the remedies available to a City department, as set forth in the applicable sales
13 contract or lease, for a Real Property Contracting Party's failure to require the payment of the
14 Prevailing Rate of Wages or the employment of Apprentices in a Covered Project, or for a Real
15 Property Contracting Party's failure to reasonably cooperate with the City in any enforcement action
16 as set forth above.

17 (g) Where the Covered Project involves Housing Development on real property sold by the
18 City, the requirements of this Article 103 shall terminate upon issuance of a final certificate of
19 occupancy for the Covered Project, so long as future construction work and/or other future activities
20 do not fall within the meaning of Covered Contract or Covered Project.

21
22 Section 10. The Labor and Employment Code is amended by adding Article 104,
23 consisting of Sections 104.1 through 104.3, to read as follows:
24
25

1 **ARTICLE 104: APPRENTICESHIP REQUIREMENTS**

2 **SEC. 104.1. EMPLOYMENT OF APPRENTICES.**

3 *Each Contractor or Subcontractor performing work as part of a project qualifying as a Covered*
4 *Real Estate Project shall employ Apprentices in compliance with the requirements of the State*
5 *Apprenticeship Program as set forth in the California Labor Code, Division 3, Chapter 4 commencing*
6 *at Section 3070, and Section 1777.5 of the California Labor Code, as each may be amended from time*
7 *to time.*

8
9 **SEC. 104.2. CONTRACTUAL APPRENTICESHIP REQUIREMENTS.**

10 *The City shall in each contract, lease, or any other type of agreement that includes or*
11 *contemplates work qualifying as a Covered Real Estate Project require that each Contractor or*
12 *Subcontractor performing work on the Covered Project employ Apprentices in accordance with Section*
13 *104.1.*

14
15 **SEC. 104.3. SUBCONTRACTORS BOUND BY APPRENTICESHIP PROVISIONS.**

16 *In each contract, lease, and/or other type of agreement that includes or contemplates work*
17 *qualifying as a Covered Real Estate Project, the City shall require the Contractor to insert in every*
18 *subcontract or other arrangement, which the Contractor or Subcontractor may make for the*
19 *performance of any work or labor on the Covered Real Estate Project, the requirement that the*
20 *Subcontractor shall employ Apprentices in accordance with Section 104.1.*

21
22 Section 11. The Labor and Employment Code is amended by adding Article 105,
23 consisting of Sections 105.1 through 105.3, to read as follows:
24
25

1 **ARTICLE 105: HOURS AND DAYS OF LABOR**

2 **SEC. 105.1. GENERALLY.**

3 For the purpose of meeting prevailing conditions and enabling employers to secure a sufficient
4 number of satisfactory workers and artisans, no person performing labor or rendering service in the
5 performance of any contract or subcontract for any Covered Project as defined in Article 101 shall
6 perform labor for a longer period than five days (Monday through Friday) of eight hours each, with
7 two 10-minute breaks per eight-hour day, except in those crafts in which a different work day or week
8 now prevails by agreement in private employment. Any person working hours in addition to the above
9 shall be compensated in accordance with the prevailing overtime standards and rates.

10
11 **SEC. 105.2. NONCOMPLIANCE AND FORFEITURE.**

12 Any Contractor or Subcontractor who violates any provision of this Article 105 shall be liable
13 for the same penalties and forfeits as those specified in Article 106; penalties and forfeits shall be
14 applicable for each laborer, mechanic, or artisan employed for each calendar day or portion thereof
15 whereon such laborer, mechanic, or artisan is compelled or permitted to work more than the days and
16 hours specified herein. The provisions of this Article 105 shall be made a part of all contracts and
17 subcontracts for any Covered Project.

18
19 **SEC. 105.3. CONTRACTS OUTSIDE CITY AND COUNTY.**

20 In the event that any Covered Project is to be constructed outside of the City and at such a
21 distance therefrom that those engaged in performing labor on the Covered Project must under ordinary
22 conditions remain at or near the site of the Covered Project when not actually engaged in the
23 performance of labor thereon, then the officer, board, or commission responsible for the construction
24 of the Covered Project may, in making specifications or letting contracts therefor, make provision
25 therein for days and hours of labor beyond the limitations provided for in Article 105; but not to exceed

1 eight hours in any calendar day, or six days in any calendar week. In the event that emergency
2 conditions arise, making a change advisable during the performance of any such contract, or any
3 portion thereof, the hours and days of labor may be extended beyond the limits hereinabove expressed;
4 but not to exceed eight hours per day, upon the written authority of the officer, board, or commission
5 awarding such contract. Failure of the Contractor to perform such contract within the time provided
6 shall not constitute an emergency.

7
8 Section 12. The Labor and Employment Code is amended by adding Article 106,
9 consisting of Sections 106.1 through 106.7, to read as follows:

10 **ARTICLE 106: PENALTIES, FORFEITURE, AND ENFORCEMENT**

11 **SEC. 106.1. PENALTY AND FORFEITURE.**

12 Any Contractor or Subcontractor who fails or neglects to comply with the requirements of
13 Article 103, Article 104, and/or Article 105 shall forfeit to the City back wages due plus penalties.
14 Penalties shall be forfeited in amounts consistent with analogous provisions of the California Labor
15 Code as amended from time to time, including Sections 1775, 1777.7, and 1813, but not less than \$50
16 for each calendar day, or portion thereof, for each worker not paid or otherwise not employed in
17 compliance with the requirements of Article 103, Article 104, and/or Article 105. A Contractor shall be
18 jointly and severally liable for the forfeitures of its Subcontractor(s). In addition, any Contractor or
19 Subcontractor who fails or neglects to comply with the requirements of Article 103, Article 104, and/or
20 Article 105 shall be subject to the penalties set forth in Article V of Chapter 6 of the Administrative
21 Code, including debarment.

22
23 **SEC. 106.2. WITHHOLDING OF FUNDS.**

24 For any Covered Project or Covered Contract under which the City has the ability to withhold
25 funds, it shall be the duty of the officer, board, or commission under whose jurisdiction said Covered

1 Project or Covered Contract is being carried on, constructed, or performed, when certifying to the
2 Controller any payment which may become due under said Contract, to deduct from said payment or
3 payments the total amount of any forfeiture provided for in Section 106.1. In doing so, the Department
4 Head must also notify in writing the Labor Standards Enforcement Officer of the Department Head's
5 action. The Labor Standards Enforcement Officer may also, upon written notice to the Department
6 Head responsible for the project, certify to the Controller any forfeiture(s) to deduct from any payment
7 as provided for in this Section 106.2. Certification of forfeitures under this Section 106.2 shall be made
8 only upon an investigation and audit by the responsible Department Head or the Labor Standards
9 Enforcement Officer and upon service of written notice to the Contractor that includes identification of
10 the grounds for the forfeiture or forfeitures ("Certification of Forfeiture"). The audit supporting the
11 forfeiture shall be appended to the Certification of Forfeiture, but failure to append such
12 documentation shall not invalidate the Certification of Forfeiture. Service of the Certification of
13 Forfeiture shall be made by United States mail and the date of service shall be the date of mailing. The
14 Controller, in issuing any warrant for any such payment, shall deduct from the amount which would
15 otherwise be due on said payment or payments the amount of said forfeiture or forfeitures as so
16 certified. This Section 106.2 does not provide for the withholding of funds disbursed through a City
17 loan for a Covered Real Estate Project.

18
19 **SEC. 106.3. WHERE THE CITY DOES NOT HAVE THE ABILITY TO WITHHOLD FUNDS.**

20 A Covered Project or Covered Contract subject to the procedures and/or requirements of
21 Section 106.2 shall not be subject to the procedures and requirements of Section 106.3. For any
22 Covered Project or Covered Contract for which the City does not have the ability to withhold funds, the
23 Labor Standards Enforcement Officer shall determine whether a Contractor and/or a Subcontractor
24 has failed to comply with the Prevailing Wage Provisions. If after conducting an investigation, the
25 Labor Standards Enforcement Officer determines that a violation has occurred, the Labor Standards

1 Enforcement Officer shall issue to and serve a Determination of Violation on the Contractor and/or any
2 Subcontractor, which sets forth the basis of the determination and orders payment of back wages due
3 plus penalties in amounts consistent with Section 106.1. A Contractor shall be jointly and severally
4 liable for the violations and liabilities set forth in a Determination of Violation issued to its
5 Subcontractor(s). Service of the Determination of Violation shall be made by United States mail and
6 the date of service shall be the date of mailing.

7
8 **SEC. 106.4. TERMINATION.**

9 In addition to and without prejudice to any other remedy available, the Department Head may
10 terminate a Covered Contract unless within 30 days of service of the Certification of Forfeiture or
11 Determination of Violation, the Contractor has either: (i) cured the violation; or (ii) established by
12 documentary evidence, including but not limited to payroll records, the truth and accuracy of which is
13 attested to by affidavit, proof of compliance with the applicable sections of the Prevailing Wage
14 Provisions. Upon a termination under this Section 106.4, the Contractor shall not be entitled to any
15 additional payment under the Covered Contract.

16
17 **SEC. 106.5. RECOURSE PROCEDURE.**

18 A Contractor and/or a Subcontractor may appeal from a Certification of Forfeiture under
19 Section 106.2 or Determination of Violation under Section 106.3. The Controller shall adopt and
20 maintain rules for any appeal under this Section 106.5, which rules shall be consistent with the
21 following:

22 (a) Any appeal from a Certification of Forfeiture or a Determination of Violation (each type
23 of appeal referred to in this Section 106.5 as the "Appeal") shall be filed in writing by the Contractor
24 and/or Subcontractor (referred to in this Section 106.5, whether individually or together, as the
25 "Appellant") within 15 days of the date of service of the Certification of Forfeiture or the

1 Determination of Violation. Appellant shall file the Appeal with the Controller and serve a copy on the
2 Labor Standards Enforcement Officer. Failure by the Contractor or Subcontractor to submit a timely,
3 written Appeal shall constitute concession to the forfeiture or determination, and the forfeiture or
4 determination shall be deemed final upon expiration of the 15-day period.

5 (b) Upon being served with the Appeal, the Office of Labor Standards Enforcement shall
6 promptly afford Appellant an opportunity to meet and confer in good faith regarding possible
7 resolution of the Certification of Forfeiture or Determination of Violation in advance of further
8 proceedings under this Section 106.5, with the intention that such meeting occur within 30 days of the
9 date the Appeal is filed.

10 (c) After the expiration of 30 days following the date the Appeal is filed, any party may
11 request in writing, with concurrent notice to all other parties, that the Controller appoint a hearing
12 officer to hear and decide the Appeal ("Hearing Officer"). If no party requests appointment of a
13 Hearing Officer, the Certification of Forfeiture or Determination of Violation shall be deemed final on
14 the 60th day after the date the Appeal is filed.

15 (d) Within 15 days of receiving a written request for appointment of a Hearing Officer
16 under subsection (c), the Controller shall appoint an impartial hearing officer and promptly notify the
17 enforcing official and Appellant, and their respective counsel or authorized representative, if any, of
18 the appointment. The Hearing Officer shall be an Administrative Law Judge with at least 10 years of
19 experience with the City and not less than two years of experience in labor law, Prevailing Wage,
20 and/or wage and hour matters; or shall be an attorney with knowledge of and not less than five years of
21 experience in labor law, Prevailing Wage, and/or wage and hour matters.

22 (e) The Hearing Officer shall promptly set a date for a hearing. The hearing shall
23 commence within 45 days of the date of the notification of the Hearing Officer appointment, and
24 conclude within 75 days of such notice. The Hearing Officer shall conduct a fair and impartial
25 evidentiary hearing in conformance with the time limitations set forth in this Section 106.5 and in the

1 rules, so as to avoid undue delay in the resolution of any appeal. The Hearing Officer shall have the
2 discretion to extend the times under this Section 106.5, and any time requirements under the rules and
3 regulations, only upon a showing of good cause.

4 (f) Appellant has the burden of proving by a preponderance of the evidence that the basis
5 for the Certification of Forfeiture or Determination of Violation is incorrect, including any back wage
6 and penalty assessments that are at issue in the Appeal.

7 (g) Within 30 days of the conclusion of the hearing, the Hearing Officer shall issue a written
8 decision affirming, modifying, or dismissing the Certificate of Forfeiture or Determination of Violation.
9 The decision of the Hearing Officer shall consist of findings and a determination. The Hearing Officer's
10 findings and determination shall be the City's final determination.

11 (h) Appellant may appeal a final determination under this Section 106.5 only by filing in the
12 San Francisco Superior Court. The Appellant may appeal the final administrative decision only by
13 filing in San Francisco Superior Court a petition for a writ of mandate under California Code of Civil
14 Procedure, Section 1094.5 et seq., as applicable, and as may be amended from time to time.

15
16 **SEC. 106.6. DISTRIBUTION OF FORFEITURE AND DAMAGES.**

17 (a) The Controller shall withhold any forfeiture as provided in Section 106.2 until such time as
18 either the Contractor or Subcontractor has conceded to the forfeiture or, in the event of an Appeal,
19 there is a determination no longer subject to judicial review. The Controller shall then distribute the
20 amounts withheld in the following order:

21 (1) the Labor Standards Enforcement Officer shall make best efforts to distribute back
22 wages withheld to the individual workers identified as not having been paid the proper wage rate;

23 (2) the penalty sums provided for above shall inure to the benefit of the general fund of
24 the City;

1 (3) the Controller shall hold the balance of any back wages in escrow for workers who
2 the Labor Standards Enforcement Officer, despite best efforts, cannot locate. In the event back wages
3 are unclaimed for a period of three years, the Controller shall undertake administrative procedures for
4 unclaimed funds in conformance with California Government Code Section 50050, et seq., as may be
5 amended from time to time.

6 (b) The order of distribution set forth in subsection (a) also shall apply to damages obtained as
7 a result of a payment on a Determination of Violation under Section 106.3 or to an enforcement action
8 pursuant to Section 106.7, as applicable.

9
10 **SEC. 106.7. REMEDIES FOR NON-COMPLIANCE WITH DETERMINATION OF VIOLATION.**

11 No later than 30 days after receipt of a Determination of Violation or, in the case of an Appeal,
12 no later than 30 days after an adverse final determination by the Hearing Officer, the Contractor
13 and/or Subcontractor shall comply with the Determination of Violation by paying the amounts due for
14 back wages and any penalty amount as set forth in the Determination of Violation or final
15 determination. The Contractor and/or Subcontractor shall, in addition, be subject to the penalties set
16 forth in Section 106.1, including debarment. If any Contractor and/or Subcontractor fails to pay the
17 amounts required under this Section 106.7 within the required 30 days, the following shall apply:

18 (a) The City may bring a civil action in a court of competent jurisdiction against the non-
19 complying party and, upon prevailing, shall be entitled to such legal and equitable relief as may be
20 appropriate to remedy the violation including, without limitation: (i) damages in the amount of back
21 wages and any penalty amounts due to workers for violation of the Prevailing Wage requirement,
22 which amounts the City shall, on receipt, distribute to workers following the procedures in Section
23 106.6; and (ii) an award of reasonable attorney's fees and costs.

24 (b) For a Covered Real Estate Project, each worker entitled to back pay, as set forth in the
25 Determination of Violation or, where a Hearing Officer has decided the matter, as set forth in the

1 decision of the Hearing Officer, may bring a civil action in a court of competent jurisdiction against the
2 non-complying party and, upon prevailing, shall be entitled to such legal and equitable relief as may be
3 appropriate to remedy the violation including, without limitation: (i) damages in the amount of back
4 wages due to such workers for violation of the prevailing wage and/or penalties due for violation of the
5 apprenticeship requirements; and (ii) an award of reasonable attorney's fees and costs. An employee
6 organization that formally represents a worker or workers entitled to bring a civil action under this
7 subsection 106.7(b) may do so on behalf of the worker or workers, with the same range of possible
8 legal and equitable relief, including attorney's fees, as would be available in an action brought by the
9 worker or workers.

10
11 Section 13. The Labor and Employment Code is amended by adding Article 107,
12 consisting of Sections 107.1 through 107.3, to read as follows:

13 **ARTICLE 107: LABOR STANDARDS ENFORCEMENT OFFICER**

14 **SEC. 107.1. LABOR STANDARDS ENFORCEMENT OFFICER.**

15 (a) Subject to the approval of the Mayor and Director of the Department of Administrative
16 Services, the Labor Standards Enforcement Officer shall develop and administer a plan for the
17 enforcement of, and is authorized to enforce, the Prevailing Wage requirements and other labor
18 standards imposed by the Charter, the Prevailing Wage Provisions, and/or Chapter 6 of the
19 Administrative Code. The Labor Standards Enforcement Officer shall coordinate the Labor Standards
20 Enforcement Officer's activities with federal and State labor standards agencies. The Labor Standards
21 Enforcement Officer shall direct the City's enforcement of the Prevailing Wage requirements and other
22 labor standards imposed by the Charter, the Prevailing Wage Provisions, and Chapter 6 of the
23 Administrative Code on Contractors as directed by the Mayor, and to this end all City departments
24 shall cooperate with the Labor Standards Enforcement Officer.

1 **(b) The Labor Standards Enforcement Officer has the authority to seek for a violation of the**
2 **Prevailing Wage Provisions, working conditions, or apprenticeship requirements all of the penalties**
3 **imposed by the Prevailing Wage Provisions and/or Chapter 6 of the Administrative Code, including the**
4 **authority to file charges, in the same manner and to the same extent as a Department Head, which may**
5 **lead to the debarment of the Contractor under Article V of Chapter 6 and/or Chapter 28 of the**
6 **Administrative Code.**

7 **(c) The Labor Standards Enforcement Officer shall oversee the training of City personnel in**
8 **the area of labor standards enforcement. In accordance with applicable law, including the civil service**
9 **provisions of the Charter, the Mayor or the City Administrator may enter into a contract for**
10 **investigative and monitoring services to further the purposes of this Article 107. In evaluating the**
11 **qualifications of persons seeking that contract, the Mayor shall consider, among other relevant factors,**
12 **the experience of those persons in monitoring and investigating labor standards compliance.**

13 **(d) This Section 107.1 shall not limit the authority and duties of the Labor Standards**
14 **Enforcement Officer established elsewhere in City law, including without limitation Section 2A.23 of**
15 **the Administrative Code.**

16
17 **SEC. 107.2. FUNDING.**

18 **Subject to the fiscal and budgetary provisions of the Charter, the Office of Labor Standards**
19 **Enforcement is authorized to receive from departments awarding contracts the amount reasonably**
20 **calculated to pay for the costs, including litigation costs, of enforcing the City Prevailing Wage**
21 **requirements and other labor standards for contracts awarded by those departments. The Labor**
22 **Standards Enforcement Officer shall supervise the expenditure of all funds appropriated for**
23 **enforcement of Prevailing Wage requirements and other labor standards imposed by the Charter, the**
24 **Prevailing Wage Provisions, and Chapter 6 of the Administrative Code.**

1 **SEC. 107.3. ADMINISTRATIVE PROCEDURE.**

2 (a) The Labor Standards Enforcement Officer shall establish an administrative procedure to
3 address allegations of labor standards violations in connection with any contract under Chapter 6 of
4 the Administrative Code or any contract for a Covered Project or Covered Contract. The Labor
5 Standards Enforcement Officer shall have sole authority over the administration of this complaint
6 procedure. The complaint procedure shall include but need not be limited to the following:

7 (1) any person may file a complaint, written or oral, alleging one or more violations of
8 any labor standards requirement imposed by the Prevailing Wage Provisions or Chapter 6 of the
9 Administrative Code on Contractors;

10 (2) before beginning to investigate the complaint, the Labor Standards Enforcement
11 Officer shall determine if the allegations of the complaint are sufficient, and based on that assessment
12 shall determine to either dismiss it or proceed with an investigation;

13 (3) if the Labor Standards Enforcement Officer at any time determines that the
14 allegations in the complaint are without merit, the Labor Standards Enforcement Officer shall notify
15 the complainant; and

16 (4) if the Labor Standards Enforcement Officer finds that any allegations in a complaint
17 have merit, the Labor Standards Enforcement Officer shall proceed in accordance with the
18 enforcement procedures under Article 106.

19 (b) Notwithstanding the foregoing, the complaint procedure in subsection (a) is not applicable
20 to those matters under the administrative jurisdiction of the Human Rights Commission.

21 (c) The complaint procedure established in subsection (a) shall not preclude the Labor
22 Standards Enforcement Officer from initiating or proceeding with an investigation on the Labor
23 Standards Enforcement Officer's own authority.

24 (d) All Contractors and departments engaged in a Covered Project or Covered Contract shall
25 cooperate fully with the Office of Labor Standards Enforcement in connection with any investigation of

1 any complaint filed in accordance with the complaint procedure established in subsection (a). The
2 Labor Standards Enforcement Officer may interview, either at the worksite or elsewhere, any witness
3 who may have information relative to a complaint.

4
5 Section 14. The Labor and Employment Code is amended by adding Article 108,
6 consisting of Sections 108.1 through 108.4, to read as follows:

7 **ARTICLE 108: LOCAL HIRE REQUIREMENT**

8 **SEC. 108.1. LOCAL HIRE REQUIREMENT.**

9 The City shall include in all real property sales contracts for Housing Development, as that
10 term is defined in Article 101, and in all City-as-landlord leases that include or contemplate
11 construction of a Covered Project, the requirement that the purchaser or tenant of the real property
12 comply with the requirements of the City's Local Hiring Policy, as set forth in Administrative Code
13 Chapter 82 and under the standards set forth in subsection 82.4(b) of the Administrative Code.
14 Notwithstanding Article 101, for purposes of this Article 108, the terms "Covered Project,"
15 "Contractor," and "Subcontractor," shall have the same meaning as the definitions set forth in Section
16 82.3 of the Administrative Code.

17
18 **SEC. 108.2. MANDATORY PARTICIPATION LEVELS.**

19 In the performance of work or labor on a Covered Project, each purchaser or tenant shall
20 comply, and shall require its Contractors and Subcontractors to comply, with the mandatory
21 participation levels set forth in Section 82.5 of the Administrative Code.

22
23 **SEC. 108.3. CITY AS THIRD PARTY BENEFICIARY.**

24 Each applicable construction contract for a Covered Project shall:

25 (a) require compliance with the Local Hiring Policy, with reference to this Article 108;

1 (b) name the City as a third party beneficiary for the limited purpose of having the right to
2 enforce the Local Hiring Policy, including the right to file charges and seek penalties against any
3 Contractor or Subcontractor; and

4 (c) require the purchaser or tenant to reasonably cooperate with the City in any action or
5 proceeding against a Contractor or Subcontractor that fails to comply with the requirements of this
6 Article 108. A purchaser or tenant that requires compliance with this Section 108.3 in the construction
7 contract for the Covered Project and reasonably cooperates with the City in any enforcement action
8 shall not be in breach of the applicable sales contract or lease with the City due to a Contractor's or
9 Subcontractor's failure to comply or to meet the mandatory participation levels. So long as the
10 purchaser or tenant complies with the requirements of the previous sentence, any enforcement action
11 by the City, through the Office of Economic and Workforce Development ("OEWD") or otherwise,
12 shall be directly against the Contractor or Subcontractor that failed to meet the mandatory
13 participation levels. But nothing in this Section 108.3 shall limit the remedies available to a City
14 department, as set forth in the applicable sales contract or lease, for a purchaser's or tenant's failure to
15 require compliance with this Section in a construction contract for the Covered Project or to
16 reasonably cooperate with the City in any enforcement action as set forth above.

17
18 **SEC. 108.4. ENFORCEMENT.**

19 (a) Assessment of Penalties. OEWD shall have the authority to enforce this Article 108
20 against a Contractor or Subcontractor as set forth in Administrative Code Section 82.8. OEWD shall
21 determine whether a Contractor or Subcontractor has failed to comply with the local hiring
22 requirements. If after conducting an investigation, OEWD determines that a violation has occurred, it
23 shall issue and serve an assessment of penalties that sets forth the basis of the assessment and orders
24 payment of penalties under subsection 82.8(f) of the Administrative Code.

1 **(b) Remedies for Non-Compliance with Assessment of Penalties. Each Contractor and**
2 **Subcontractor shall comply with the final assessment of penalties by paying the amounts due for wages**
3 **as set forth in Administrative Code subsection 82.8(f)(3) no later than 30 days after the determination**
4 **or decision of the hearing officer is final. The Contractor or Subcontractor shall, in addition, be subject**
5 **to the penalties set forth in Article V of Chapter 6 of the Administrative Code, including debarment. If**
6 **any Contractor or Subcontractor fails to pay the amounts required under subsection 82.8(f) of the**
7 **Administrative Code within the required 30 days, the non-complying party shall be subject to the**
8 **enforcement actions set forth in subsection 82.8(f)(5) of the Administrative Code.**

9
10 Section 15. The Labor and Employment Code is amended by adding Article 109,
11 consisting of Sections 109.1 through 109.14, to read as follows:

12 **ARTICLE 109: TRANSITION EMPLOYMENT REQUIREMENTS**

13 **SEC. 109.1. PURPOSE AND SCOPE.**

14 **(a) The City has an important proprietary interest in maintaining the stability of the**
15 **workforce engaged by a Contractor or Subcontractor under a Covered Contract. Turnover of**
16 **experienced workers resulting from a change in the City's Contractor jeopardizes the quality,**
17 **efficiency, and cost-effectiveness of service provided to the City under the successor Contract.**
18 **Accordingly, all Covered Contracts shall impose the obligations of this Article 109 on the Contractor**
19 **and Subcontractor.**

20 **(b) Article 109 does not apply to any Covered Project, unless that Covered Project also**
21 **qualifies as a Covered Contract.**

22
23 **SEC. 109.2. SUBMISSION OF EMPLOYEE INFORMATION.**

24 **(a) Where the Contracting Officer has given notice that a Covered Contract will be bid, or**
25 **where a Contractor has given notice of termination, upon giving or receiving such notice, as the case**

1 may be, the Contractor ("ending Contractor") shall, within 10 days thereafter, provide to the
2 Contracting Officer and the Purchaser, for each Employee who worked at least 15 hours per week for
3 the ending Contractor, the name, date of hire, number of hours and months worked in total for the
4 employer, wage rate, and employment occupation classification. This provision shall also apply to the
5 subcontractors of the ending Contractor.

6 (b) Where a Subcontractor has been terminated prior to the termination or ending of the
7 Contract, the Subcontractor shall for the purposes of this Section 109.2 be deemed an ending
8 Contractor.

9 (c) All requests for bids for Covered Contracts shall include the information listed above for
10 Employees and shall notify prospective bidders about the Transition Employment requirements of this
11 Article 109.

12
13 **SEC. 109.3. EMPLOYEE RETENTION.**

14 A successor Contractor shall retain, for a six-month transition employment period, Employees
15 who have worked at least 15 hours per week for the ending Contractor or its Subcontractors for the
16 preceding 12 months and have been employed by the ending Contractor or its Subcontractors, if any,
17 for the preceding 12 months under the Covered Contract, providing that just cause does not exist to
18 terminate such Employee. The ending Contractor's Employees who worked at least 15 hours per week
19 shall be employed by the Successor Contractor in order of their seniority with the ending Contractor
20 within their job classification, and shall be paid the Prevailing Rate of Wages to which they were
21 entitled when employed by the ending Contractor. This requirement shall be stated by the City in all
22 initial bid packages involving a Covered Contract.

1 **SEC. 109.4. INSTANCES WHERE FEWER EMPLOYEES ARE REQUIRED.**

2 If at any time a successor Contractor determines that fewer Employees are required to perform
3 the new Contract than were required by the ending Contractor (and Subcontractors, if any), the
4 successor Contractor shall retain Employees by seniority within job classification.

5
6 **SEC. 109.5. PREFERENTIAL HIRING LIST.**

7 During such six-month period the successor Contractor (or Subcontractor, where applicable)
8 shall maintain a preferential hiring list of eligible covered Employees not retained by the successor
9 Contractor (or Subcontractor) from which the successor Contractor (or Subcontractor) shall hire
10 additional Employees if the need arises.

11
12 **SEC. 109.6. RESTRICTION ON DISCHARGING EMPLOYEES.**

13 During the six-month transition employment period, the successor Contractor (or
14 Subcontractor, where applicable) shall not discharge without cause an Employee retained pursuant to
15 Article 109. "Cause," for this purpose, shall include, but not be limited to, the Employee's conduct
16 while in the employ of the ending Contractor or Subcontractor that contributed to any decision to
17 terminate the Contract or subcontract for fraud or poor performance, excluding permissible union-
18 related activity.

19
20 **SEC. 109.7. PERFORMANCE REVIEWS.**

21 At the end of the six-month transition employment period, a successor Contractor (or
22 Subcontractor, where applicable) shall perform a written performance evaluation for each Employee
23 retained pursuant to this Article 109. If the Employee's performance during such six-month period is
24 satisfactory, the successor Contractor (or Subcontractor) shall offer the Employee continued
25

1 employment under the terms and conditions established by the successor Contractor (or Subcontractor)
2 or as required by law.

3
4 **SEC. 109.8. CONTRACTUAL PROVISIONS.**

5 All Covered Contracts subject to this Article 109 shall include a provision in which the
6 Contractor agrees to require any Subcontractor to comply with the obligation imposed by this Article
7 109.

8
9 **SEC. 109.9. SUCCESSOR'S PRIOR EMPLOYEES.**

10 Notwithstanding the provisions of this Article 109, a successor Contractor or Subcontractor
11 may replace an Employee otherwise entitled to be retained with a person employed by the Contractor
12 or Subcontractor continuously for 12 months prior to the commencement of the successor Contract or
13 Subcontract in a capacity similar to that proposed under the successor Contract or Subcontract. This
14 provision shall apply only where the existing Employee of the successor Contractor or Subcontractor
15 would otherwise be laid off work as a result of the award of the successor Contract.

16
17 **SEC. 109.10. NO SUCCESSOR.**

18 The retention requirements of this Article 109 shall not apply where there is no successor
19 Contractor or Subcontractor. For example, where a Contract is for services over a single day, week, or
20 month for a discrete, nonrepeating event, there is no successor and the retention requirements
21 described herein are inapplicable.

22
23 **SEC. 109.11. DEFINITION OF EMPLOYEE.**

24 For the purposes of this Article 109 on Transition Employment Requirements only, the term
25 "Employee" shall include any person who performs work under a Covered Contract, but shall not

1 include an individual who serves in a managerial, supervisory, or confidential capacity, including
2 those individuals who would be defined as such under the Fair Labor Standards Act, 29 U.S.C. § 201,
3 et seq., as may be amended from time to time.

4
5 **SEC. 109.12. ENFORCEMENT.**

6 (a) **Definitions.** For the purpose of Sections 109.12 and 109.13, “Agency” means the Office
7 of Labor Standards Enforcement or any successor department or office.

8 (b) **Implementation.** The Agency shall be authorized to coordinate implementation and
9 enforcement of this Article 109 and may promulgate appropriate rules for such purposes. Any rules
10 promulgated by the Agency shall have the force and effect of law and may be relied on by employers,
11 employees, and other persons to determine their rights and responsibilities under this Article. Any rules
12 may establish procedures for ensuring fair, efficient, and cost-effective implementation of this Article,
13 including supplementary procedures for helping to inform employees of their rights under this Article,
14 for monitoring contractor, subcontractor, and awarding authority compliance with this Article, and for
15 providing administrative hearings to determine whether a contractor, subcontractor, awarding
16 authority, or other person has violated the requirements of this Article.

17 (c) **Administrative Enforcement.**

18 (1) The Agency is authorized to take appropriate steps to enforce this Article 109. The
19 Agency may investigate any possible violations of this Article by an awarding authority, a successor
20 Contractor, or a successor Contractor’s Subcontractor. Where the Agency has reason to believe that a
21 violation has occurred, it may order any appropriate temporary or interim relief to mitigate the
22 violation or maintain the status quo pending completion of a full investigation or hearing.

23 (2) Where the Agency determines that a violation has occurred, it may issue a
24 Determination of Violation and order any appropriate relief including, but not limited to, back pay,
25

1 including the value of benefits, for each day during which the violation continues, which shall be
2 calculated at a rate of compensation not less than the higher of:

3 (A) The average regular rate of pay received by the Employee during the last
4 three years of the Employee's employment in the same job classification; or

5 (B) The final regular rate received by the Employee.

6 (3) Where the Agency determines that a violation has occurred, it may also authorize the
7 payment of an additional sum as an administrative penalty to each Employee or person whose rights
8 under this Article 109 were violated. If any backpay is ordered, the dollar amount of the backpay
9 multiplied by three, or \$250, whichever amount is greater, shall be included in the administrative
10 penalty paid to the Employee. In addition, if a violation of this Article 109 resulted in other harm to the
11 Employee or any other person, or otherwise violated the rights of Employees or other persons, this
12 administrative penalty shall also include \$50 to each Employee or person whose rights under this
13 Article were violated for each day or portion thereof that the violation occurred or continued.

14 (4) Where prompt compliance is not forthcoming, the Agency may take any appropriate
15 enforcement action to secure compliance, including initiating a civil action pursuant to Section
16 109.12(d) and/or, except where prohibited by State or federal law, requesting that City agencies or
17 departments revoke or suspend any registration certificates, permits, or licenses held or requested by
18 the violator until such time as the violation is remedied. In order to compensate the City for the costs of
19 investigating and remedying the violation, the Agency may also order the violator to pay to the City a
20 sum of not more than \$50 for each day or portion thereof and for each Employee or person as to whom
21 the violation occurred or continued. Such funds shall be allocated to the Agency and used to offset the
22 costs of implementing and enforcing this Article 109.

23 (5) The remedies and penalties provided under subsections (c)(2) through (c)(4) are
24 cumulative.

1 (6) An Employee or other person may report to the Agency any suspected violation of
2 this Article 109. The Agency shall encourage reporting pursuant to this subsection (c)(5) by keeping
3 confidential, to the maximum extent permitted by applicable laws, the name and other identifying
4 information of the Employee or person reporting the violation; provided, however, that with the
5 authorization of such person, the Agency may disclose their name and identifying information as
6 necessary to enforce this Article or for other appropriate purposes.

7 (7) The Determination of Violation shall provide notice of the right to appeal the
8 determination to the Controller in accordance with Section 109.13, and that failure to do so within 15
9 days shall result in the determination becoming a final administrative decision.

10 (8) The Determination of Violation shall specify a reasonable time period for payment of
11 any relief ordered. The Agency may award interest on all amounts due and unpaid at the expiration of
12 such time period at the rate of interest specified in subdivision (b) of Section 3289 of the California
13 Civil Code, as may be amended from time to time.

14 (9) The Agency may require that remedies and penalties due and owing to a person
15 whose rights under this Article 109 were violated be paid directly to the City for disbursement to the
16 person. The Controller shall hold these funds in escrow for the person. The Agency shall make best
17 efforts to distribute such funds. In the event such funds are unclaimed for a period of three years, the
18 Controller may undertake administrative procedures for escheat of unclaimed funds under California
19 Government Code Sections 50050 et seq., as may be amended from time to time. Subject to the
20 budgetary and fiscal provisions of the Charter, such escheated funds shall be dedicated to the
21 enforcement of this Article 109 or other laws the Agency enforces.

22 **(d) Civil Enforcement.**

23 (1) The City Attorney or an Employee who, in violation of this Article 109, was not
24 retained by a successor Contractor or its Subcontractor may bring an action in the Superior Court of
25 the State of California against the successor Contractor and, where applicable, the successor

1 Contractor's Subcontractor, and an Employee may be awarded back pay, including the value of
2 benefits, for each day during which the violation continues, which shall be calculated at a rate of
3 compensation not less than the higher of:

4 (A) The average regular rate of pay received by the Employee during the last
5 three years of the Employee's employment in the same occupation classification; or

6 (B) The final regular rate received by the Employee.

7 (2) If the City Attorney or the Employee is the prevailing party in any such legal action,
8 the Court shall award reasonable attorneys' fees and costs as part of the costs recoverable.

9 (e) **Interest.** In any administrative or civil action brought under this Article 109, the Agency
10 or court, as the case may be, shall award interest on all amounts due and unpaid at the rate of interest
11 specified in subdivision (b) of Section 3289 of the California Civil Code, as amended from time to time.

12
13 **SEC. 109.13. APPEAL PROCEDURE.**

14 (a) A person subject to a Determination of Violation of this Article 109 may file an appeal
15 ("Appeal") in accordance with the following procedures:

16 (1) The person ("Appellant") shall file the Appeal with the Controller and serve a copy
17 on the Agency. The Appeal shall be filed in writing within 15 days of the date of service of the
18 Determination of Violation, and shall specify the basis for the Appeal and shall request that the
19 Controller appoint a hearing officer to hear and decide the Appeal. Failure to submit a timely written
20 Appeal shall constitute concession, and the Determination of Violation shall be deemed the final
21 administrative decision upon expiration of the 15-day period. Further, failure to submit a timely,
22 written Appeal shall constitute a failure to exhaust administrative remedies, which shall serve as a
23 complete defense to any petition or claim brought against the City regarding the Determination of
24 Violation.

1 (2) Following the filing of the Appeal and service of a copy on the Agency, the Agency
2 shall promptly afford the Appellant an opportunity to meet and confer in good faith regarding possible
3 resolution of the Determination of Violation.

4 (3) Within 30 days of receiving an Appeal, the Controller shall appoint an impartial
5 hearing officer who is not part of the Agency and immediately notify the Agency and Appellant of the
6 appointment.

7 (4) The hearing officer shall promptly set a date for a hearing. The hearing shall
8 commence within 45 days of the date of the Controller's notice of appointment of the hearing officer,
9 and conclude within 75 days of such notice; provided, however, that the hearing officer may extend
10 these time limits for good cause.

11 (5) The hearing officer shall conduct a fair and impartial evidentiary hearing. The
12 Appellant shall have the burden of proving by a preponderance of the evidence that the Agency erred in
13 its Determination of Violation, and/or the relief ordered therein.

14 (6) Within 30 days of the conclusion of the hearing, the hearing officer shall issue a
15 written decision affirming, modifying, or dismissing the Determination of Violation. The hearing
16 officer's decision shall be the final administrative decision. The decision shall consist of findings, a
17 determination, any relief ordered, a reasonable time period for payment of any relief ordered, and
18 notice to the Appellant of the right to appeal by filing a petition for a writ of mandate as described in
19 subsection (a)(7), and that failure to file a timely Appeal shall result in the final administrative decision
20 becoming enforceable as a judgment by the Superior Court.

21 (7) The Appellant may appeal the final administrative decision only by filing in San
22 Francisco Superior Court a petition for a writ of mandate under California Code of Civil Procedure,
23 Section 1094.5 et seq., as applicable, and as may be amended from time to time.

24 (b) Where an Appellant fails to comply with a final administrative decision within the time
25 period required therein, the Agency may take any appropriate enforcement action to secure

1 compliance, including referring the action to the City Attorney to seek enforcement of the final
2 administrative decision in Superior Court and, except where prohibited by State or federal law,
3 requesting that City agencies or departments revoke or suspend any registration certificates, permits,
4 or licenses held or requested by the Appellant until such time as the violation is remedied.

5
6 **SEC. 109.14. NO PRIVATE RIGHT OF ACTION.**

7 This Article is not intended to create a private right of action against the City.
8

9 Section 16. Effective Date and Operative Date.

10 (a) This ordinance shall become effective 30 days after enactment. Enactment occurs
11 when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not
12 sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the
13 Mayor's veto of the ordinance.

14 (b) This ordinance shall become operative 30 days after its effective date.
15

16 Section 17. Scope of Ordinance.

17 In enacting this ordinance, the Board of Supervisors intends to amend only those
18 words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks,
19 charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly
20 shown in this ordinance as additions, deletions, Board amendment additions, and Board
21 amendment deletions in accordance with the "Note" that appears under the official title of the
22 ordinance.

23 Section 18. Prospective Effect.

24 (a) Except as expressly stated herein, this ordinance is intended to have prospective
25 effect only, and shall not be interpreted to impair the obligations of any contract, grant

1 agreement, sales contract, lease, development agreement, or other agreement entered into
2 by the City prior to the Operative Date of this ordinance. Any contract, grant agreement, sales
3 contract, lease, development agreement, or other agreement entered into by the City prior to
4 the Effective Date of this ordinance shall be interpreted according to the provisions of the
5 Municipal Code effective at the time of the agreement, including any provisions specifying
6 prospective or retroactive effect.

7 (b) This ordinance shall not amend or repeal the prospective effect provision or
8 provisions of any ordinance or resolution enacted prior to the enactment of this ordinance.

9 (c) The foregoing notwithstanding, this ordinance shall apply to any contract, grant
10 agreement, sales contract, lease, development agreement, or other agreement entered into
11 by the City that is amended after the Effective Date of this ordinance.

Ordinance amending the Administrative Code and Labor and Employment Code to move certain employment-related provisions, including, among others, certain Prevailing Wage requirements, apprenticeship requirements, and hours and days of labor requirements, from the Administrative Code to the Labor and Employment Code; establish new defined terms encompassing the projects and contracts subject to Prevailing Wage requirements; revise penalty and enforcement requirements and procedures for Prevailing Wage and certain other labor requirements; change the process for fixing and determining Prevailing Wage rates; move and revise the Transition Employment requirements and create new enforcement procedures for those requirements; apply Notice of Forfeiture/Certification of Forfeiture procedures for violations of Prevailing Wage requirements on Covered Real Estate Projects; renumber certain Municipal Code sections or provisions; and make other substantive or technical amendments to the Administrative Code and Labor and Employment Code, including, among others, eliminating certain exemptions from Prevailing Wage requirements for Broadcast Services work and the work of loading and unloading Commercial Vehicles on City property, while creating an exemption from Prevailing Wage requirements for work covered by the Modular Furniture Installers (Carpenters) classification.
