

1 [Planning, Building Codes - Conditional Use Required to Remove Any Residential Unit;  
2 Mandatory Legalization of Illegal Units; Permeable Surfaces and Landscaping Requirements]

3  
4 **Ordinance amending the Planning Code to require Conditional Use authorization for**  
5 **the removal of any residential unit (whether legal or illegal) and compliance with**  
6 **landscaping and permeable surfaces requirements for building additions and**  
7 **residential mergers, and to exempt from the Conditional Use application requirement**  
8 **illegal units where is no legal path for legalization, ~~and residential units that have~~**  
9 **received prior Planning approval, and single-family homes that are demonstrably**  
10 **unaffordable or unsound; amending the Building Code to require that notices of**  
11 **violation mandate legalization of an illegal unit unless infeasible under the Building**  
12 **Code or the Planning Commission approves its removal, and requiring re-issuance of**  
13 **unabated notices of violation to include the new requirement; affirming the Planning**  
14 **Department’s determination under the California Environmental Quality Act; and**  
15 **making findings of consistency with the General Plan, Planning Code, Section 302, and**  
16 **the eight priority policies of Planning Code, Section 101.1.**

24 Be it ordained by the People of the City and County of San Francisco:

25 Section 1. Findings.

1 (a) The Planning Department has determined that the actions contemplated in this  
2 ordinance comply with the California Environmental Quality Act (California Public Resources  
3 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of  
4 Supervisors in File No. 160115 and is incorporated herein by reference. The Board affirms  
5 this determination.

6 (b) On December 10, 2015, the Planning Commission, in Resolution No. 19532,  
7 adopted findings that the actions contemplated in this ordinance are consistent, on balance,  
8 with the City's General Plan and the eight priority policies of Planning Code Section 101.1.  
9 The Board adopts these findings as its own. A copy of said Resolution is on file with the Clerk  
10 of the Board of Supervisors in File No. 160115, and is incorporated herein by reference.

11 (c) Pursuant to Planning Code Section 302, this Board finds that these Planning  
12 Code amendments will serve the public necessity, convenience, and welfare for the reasons  
13 set forth in Planning Commission Resolution No. 19532 and the Board incorporates such  
14 reasons herein by reference.

15  
16 Section 2. The Planning Code is hereby amended by revising Sections 132 and 317,  
17 to read as follows:

18 **SEC. 132. FRONT SETBACK AREAS, RTO, RH AND RM DISTRICTS AND FOR**  
19 **REQUIRED SETBACKS FOR PLANNED UNIT DEVELOPMENTS.**

20 The following requirements for minimum front setback areas shall apply to every  
21 building in all RH, RTO, and RM Districts, in order to relate the setbacks provided to the  
22 existing front setbacks of adjacent buildings. Buildings in RTO Districts which have more than  
23 75 feet of street frontage are additionally subject to the Ground Floor Residential Design  
24 Guidelines, as adopted and periodically amended by the Planning Commission. Planned Unit  
25

1 Developments or PUDs, as defined in Section 304, shall also provide landscaping in required  
2 setbacks in accord with Section 132(g).

3 \* \* \* \*

4 (g) **Landscaping and Permeable Surfaces.** The landscaping and permeable  
5 surface requirements of this Section and Section (h) below shall be met by the permittee in  
6 the case of construction of a new building; the addition of a new Dwelling Unit, a garage, or  
7 additional parking; any addition to a structure that would result in an increase of 20% or more of the  
8 existing Gross Floor Area, as defined in Section 102; a Residential Merger, as defined in Section 317;  
9 or paving or repaving more than 200 square feet of the front setback. All front setback areas  
10 required by this Section 132 shall be appropriately landscaped, meet any applicable water use  
11 requirements of Administrative Code Chapter 63, and in every case not less than 20 percent  
12 of the required setback area shall be and remain unpaved and devoted to plant material,  
13 including the use of climate appropriate plant material as defined in Public Works Code  
14 Section 802.1. For the purposes of this Section, permitted obstructions as defined by Section  
15 136(c)(6) chimneys, Section 136(c)(14) steps stairs, and Section 136(c)(26) (27) underground  
16 garages, shall be excluded from the front setback area used to calculate the required  
17 landscape and permeable surface area. If the required setback area is entirely taken up by  
18 one or more permitted obstructions, the Zoning Administrator may allow the installation of  
19 sidewalk landscaping that is compliant with applicable water use requirements of Chapter 63  
20 of the Administrative Code to satisfy the requirements of this Section, subject to permit  
21 approval from the Department of Public Works in accordance with Public Works Code Section  
22 810B.

24 **SEC. 317. LOSS OF ~~DWELLING~~ RESIDENTIAL AND UNAUTHORIZED UNITS THROUGH**  
25 **DEMOLITION, MERGER AND CONVERSION.**

1           \* \* \* \*

2           (b)   **Definitions.** For the purposes of this Section 317, the terms below shall be  
3 defined as follows:

4           (1)   "Residential Conversion" shall mean the removal of cooking facilities,  
5 change of occupancy (as defined and regulated by the Building Code), or change of use (as  
6 defined and regulated by the Planning Code), of any Residential Unit or Unauthorized Unit to a  
7 ~~Non-Residential~~ or Student Housing use.

8           \* \* \* \*

9           (7)   "Residential Merger" shall mean the combining of two or more *legal*  
10 Residential or Unauthorized Units, resulting in a decrease in the number of Residential Units  
11 and Unauthorized Units within a building, or the enlargement of one or more existing units while  
12 substantially reducing the size of others by more than 25% of their original floor area, even if  
13 the number of units is not reduced. The Planning Commission may reduce the numerical  
14 element of this criterion by up to 20% of its value should it deem that adjustment is necessary  
15 to implement the intent of this Section 317, to conserve existing housing and preserve  
16 affordable housing.

17           \* \* \* \*

18           (10) "Removal" shall mean, with reference to a Residential or Unauthorized  
19 Unit, its Conversion, Demolition, or Merger.

20           \* \* \* \*

21           (12) "Residential Unit" shall mean a legal conforming or *legal* nonconforming  
22 Dwelling Unit, ~~or~~ a legal nonconforming Live/Work Unit or Group Housing, which are defined  
23 in Section 102 of this Code.

24           (13) "Unauthorized Unit" shall mean one or more rooms within a building that have  
25 been used, without the benefit of a building permit, as a separate and distinct living or sleeping space

1 independent from Residential Units on the same property. "Independent" shall mean that (i) the space  
2 has independent access that does not require entering a Residential Unit on the property and (ii) there  
3 is no open, visual connection to a Residential Unit on the property.

4 (14) "Vertical Envelope Elements" shall mean all exterior walls that provide  
5 weather and thermal barriers between the interior and exterior of the building, or that provide  
6 structural support to other elements of the building envelope.

8 (c) **Applicability; Exemptions.**

9 (1) ~~An Any~~ application for a permit that would result in the ~~loss~~ Removal of one  
10 or more Residential Units or Unauthorized Units is required to obtain Conditional Use  
11 authorization; ~~provided, however, that in the RTO, RTO-M, NCT, and Upper Market NCD Zoning~~  
12 ~~Districts, as well as the loss of any residential unit above the ground floor in the C-3 Zoning District,~~  
13 ~~only the Removal of a Residential Unit or Unauthorized Unit above the ground floor requires a~~  
14 ~~Conditional Use authorization. The application for a replacement building or alteration permit~~  
15 ~~shall also be subject to Conditional Use requirements. When considering whether to grant~~  
16 ~~Conditional Use authorization for the loss of dwelling unit(s) in the C-3 districts, in lieu of the criteria~~  
17 ~~set forth in Planning Code Section 303, consideration shall be given to the adverse impact on the~~  
18 ~~public health, safety, and general welfare of the loss of housing stock in the district and to any~~  
19 ~~unreasonable hardship to the applicant if the permit is denied. Any application for a permit that would~~  
20 ~~result in the loss or Removal of three or more Residential Units, notwithstanding any other sections of~~  
21 ~~this Code, shall require a Conditional Use authorization for the Removal and replacement of the units.~~  
22 ~~Approval of any other application that would result in the loss or Removal of up to two Residential~~  
23 ~~Units is prohibited unless the Planning Commission approves such permit application and the~~  
24 ~~replacement structure permit application at a Mandatory Discretionary Review hearing, with certain~~  
25 ~~exceptions specified below.~~

1           (2) The Conditional Use requirement of Subsection (c)(1) shall apply to (A)  
2 any building or site permit issued for Removal of an Unauthorized Unit on or after March 1,  
3 2016, and (B) any permit issued for Removal of an Unauthorized Unit prior to March 1, 2016  
4 that has been suspended by the City or in which the applicant's rights have not vested.

5           (23) The Removal of a Residential or Unauthorized Unit that has received approval  
6 from the Planning Department through administrative approval or the Planning Commission through a  
7 Discretionary Review or Conditional Use authorization prior to the effective date of the Conditional  
8 Use requirement of Subsection (c)(1) is not required to apply for an additional approval under  
9 Subsection (c)(1).

10           (34) The Removal of an Unauthorized Unit does not require a Conditional Use  
11 authorization pursuant to Subsection (c)(1) if the Department has determined that there is no legal path  
12 for legalization.

13           (5) The Demolition of a Single-Family Residential Building that meets the  
14 requirements of Section (d)(3) below may be approved by the Department without requiring a  
15 Conditional Use authorization.

16           (d)   **Demolition.**

17           (1)   No permit to Demolish a Residential Building in any zoning district shall  
18 be issued until a building permit for the replacement structure is finally approved, unless the  
19 building is determined to pose a serious and imminent hazard as defined in the Building Code.  
20 A building permit is finally approved if the Board of Appeals has taken final action for approval  
21 on an appeal of the issuance or denial of the permit or if the permit has been issued and the  
22 time for filing an appeal with the Board of Appeals has lapsed with no appeal filed.

23           (2)   ~~If~~ Conditional Use authorization is required for approval of the permit for  
24 Residential Demolition ~~by other sections of this Code,~~ and the Commission shall consider the  
25 replacement structure as part of its decision on the Conditional Use application. If Conditional

1 Use authorization is required for the replacement structure by other sections of this Code, the  
2 Commission shall consider the demolition as part of its decision on the Conditional Use  
3 application. ~~In either case, Mandatory Discretionary Review is not required, although the Commission~~  
4 ~~shall apply appropriate criteria adopted under this Section 317 in addition to the criteria in Section~~  
5 ~~303 of the Planning Code in its consideration of Conditional Use authorization. If neither permit~~  
6 ~~application is subject to Conditional Use authorization, then separate Mandatory Discretion Review~~  
7 ~~cases shall be heard to consider the permit applications for the demolition and the replacement~~  
8 ~~structure.~~

9 (3) For those applications for a Residential Demolition in districts that require  
10 Mandatory Discretionary Review, administrative review criteria shall ensure that only aAn  
11 application to demolish a Single-Family Residential Building that is demonstrably not  
12 affordable or financially accessible housing, or Residential Buildings of two units or fewer that are  
13 found to be unsound housing, is exempt from the Conditional Use authorization requirement of  
14 Section (c)(1). Mandatory Discretionary Review hearings. Specific numerical criteria for such  
15 analyses shall be adopted by the Planning Commission in the Code Implementation  
16 Document, in accordance with this Section 317, and shall be adjusted periodically by the  
17 Zoning Administrator based on established economic real estate and construction indicators.

18 (A) The Planning Commission shall determine a level of affordability or  
19 financial accessibility, such that Single-Family Residential Buildings on sites in RH-1 and RH-  
20 1(D) Districts that are demonstrably not affordable or financially accessible, that is, housing  
21 that has a value greater than at least 80% of the combined land and structure values of  
22 single-family homes in San Francisco as determined by a credible appraisal, made within six  
23 months of the application to demolish, are not subject to a Conditional Use hearing. The  
24 demolition and replacement building applications shall undergo notification as required by  
25 other sections of this Code. The Planning Commission, in the Code Implementation

1 Document, may increase the numerical criterion in this Subsection by up to 10% of its value  
2 should it deem that adjustment is necessary to implement the intent of this Section 317, to  
3 conserve existing housing and preserve affordable housing.

4 (B) The Planning Commission, in the Code Implementation Document,  
5 shall adopt criteria and procedures for determining the soundness of a structure proposed for  
6 demolition, where "soundness" is an economic measure of the feasibility of upgrading a  
7 residence that is deficient with respect to habitability and Housing Code requirements, due to  
8 its original construction. The "soundness factor" for a structure shall be the ratio of a  
9 construction upgrade cost (i.e., an estimate of the cost to repair specific habitability  
10 deficiencies) to the replacement cost (i.e., an estimate of the current cost of building a  
11 structure the same size as the existing building proposed for demolition), expressed as a  
12 percent. A building is unsound if its soundness factor exceeds 50%. A Residential Building  
13 that is unsound may be approved for demolition.

14 *(C) — The Planning Commission shall consider the following additional criteria*  
15 *in the review of applications for Residential Demolition:*

16 *(i) — whether the property is free of a history of serious, continuing*  
17 *Code violations;*

18 *(ii) — whether the housing has been maintained in a decent, safe, and*  
19 *sanitary condition;*

20 *(iii) — whether the property is an "historical resource" under CEQA;*

21 *(iv) — whether the removal of the resource will have a substantial*  
22 *adverse impact under CEQA;*

23 *(v) — whether the project converts rental housing to other forms of*  
24 *tenure or occupancy;*



1 (vi) — ~~whether the project removes rental units subject to the Rent~~  
2 ~~Stabilization and Arbitration Ordinance or affordable housing;~~

3 (vii) — ~~whether the project conserves existing housing to preserve~~  
4 ~~cultural and economic neighborhood diversity;~~

5 (viii) — ~~whether the project conserves neighborhood character to~~  
6 ~~preserve neighborhood cultural and economic diversity;~~

7 (ix) — ~~whether the project protects the relative affordability of existing~~  
8 ~~housing;~~

9 (x) — ~~whether the project increases the number of permanently~~  
10 ~~affordable units as governed by Section 415;~~

11 (xi) — ~~whether the project locates in-fill housing on appropriate sites in~~  
12 ~~established neighborhoods;~~

13 (xii) — ~~whether the project increases the number of family-sized units on-~~  
14 ~~site;~~

15 (xiii) — ~~whether the project creates new supportive housing;~~

16 (xiv) ~~whether the project is of superb architectural and urban design,~~

20 (xvi) — ~~whether the project increases the number of on-site bedrooms.~~

21 (4) ~~(3)~~ Nothing in this Section is intended to permit Residential Demolition in  
22 those areas of the City where other sections of this Code prohibit such demolition or  
23 replacement structure.

24 (5) ~~(4)~~ Nothing in this Section is intended to exempt buildings or sites where  
25 demolition is proposed from undergoing review with respect to Articles 10 and 11 of the

1 Planning Code, where the requirements of those articles apply. Notwithstanding the definition  
2 of "Residential Demolition" in this section and as further described in the Code  
3 Implementation Document with regard to Residential Demolition, the criteria of Section 1005  
4 shall apply to projects subject to review under the requirements of Article 10 with regard to the  
5 structure itself.

6 (e) Conversion to Student Housing. The conversion of Residential Units to Student  
7 Housing is prohibited. For the purposes of this subsection, Residential Units that have been defined as  
8 such by the time a First Certificate of Occupancy has been issued by the Department of Building  
9 Inspection for new construction shall not be converted to Student Housing.

10 (f) Residential Merger. The Merger of Residential Units, not otherwise subject to  
11 Conditional Use authorization by this Code, shall be prohibited.

12 (g) Conditional Use Criteria.

13 (1) C-3 Districts. When considering whether to grant Conditional Use authorization  
14 for the loss or Removal of Residential or Unauthorized Unit(s) in the C-3 districts, in lieu of the criteria  
15 set forth in Planning Code Section 303, consideration shall be given to the adverse impact on the  
16 public health, safety, and general welfare of the loss of housing stock in the district and to any  
17 unreasonable hardship to the applicant if the permit is denied.

19 ~~(e) (2) Residential Merger.~~

20 ~~(1) — The Merger of Residential Units, not otherwise subject to Conditional Use~~  
21 ~~authorization by this Code., shall be prohibited, unless the Planning Commission approves the building~~  
22 ~~permit application at a Mandatory Discretionary Review hearing, applying the criteria in subsection~~  
23 ~~(2) below, or the project qualifies for administrative approval and the Planning Department approves~~  
24 ~~the project administratively in accordance with subsection (3) below.~~

1           ~~(2)~~     The Planning Commission shall consider the following criteria in the  
2 review of applications to merge Residential Units or Unauthorized Units:

3                   (A)     whether removal of the unit(s) would eliminate only owner  
4 occupied housing, and if so, for how long the unit(s) proposed to be removed have been  
5 owner occupied;

6                   (B)     whether removal of the unit(s) and the merger with another is  
7 intended for owner occupancy;

8                   (C)     whether ~~the~~ removal of the unit(s) will remove an affordable  
9 housing unit as defined in Section ~~401 415~~ of this Code or housing subject to the Residential  
10 Rent Stabilization and Arbitration Ordinance;

11                   ~~(D) — whether removal of the unit(s) will bring the building closer into~~  
12 ~~conformance with prescribed zoning;~~

13                   ~~(E) — (D)~~ if removal of the unit(s) removes an affordable housing unit as  
14 defined in Section 401 of this Code or units subject to the Residential Rent Stabilization and

1                   (3) — *Administrative review criteria shall ensure that only those Residential Units*  
2 *proposed for Merger that are demonstrably not affordable or financially accessible housing are exempt*  
3 *from Mandatory Discretionary Review hearings. Applications for which the least expensive unit*  
4 *proposed for merger has a value greater than at least 80% of the combined land and structure values*  
5 *of single family homes in San Francisco, as determined by a credible appraisal, made within six*  
6 *months of the application to merge, are not subject to a Mandatory Discretionary Review hearing. The*  
7 *Planning Commission, in the Code Implementation Document, may increase the numerical criterion in*  
8 *this subsection by up to 10% of its value should it deem that adjustment is necessary to implement the*  
9 *intent of this Section 317, to conserve existing housing and preserve affordable housing.*

10                   (4)     The Planning Commission shall not approve an application for Residential  
11 Merger if any tenant has been evicted pursuant to Administrative Code Sections 37.9(a)(9)  
12 through 37.9(a)(14) where the tenant was served with a notice of eviction after December 10,  
13 2013 if the notice was served within ~~ten~~ (10) years prior to filing the application for merger.  
14 Additionally, the Planning Commission shall not approve an application for Residential  
15 Merger if any tenant has been evicted pursuant to Administrative Code Section 37.9(a)(8)  
16 where the tenant was served with a notice of eviction after December 10, 2013 if the notice  
17 was served within five (5) years prior to filing the application for merger. This Subsection ~~(e)(4)~~  
18 (g)(2)(H) shall not apply if the tenant was evicted under Section 37.9(a)(11) or 37.9(a)(14) and  
19 the applicant(s) either (A) have certified that the original tenant reoccupied the unit after the  
20 temporary eviction or (B) have submitted to the Planning Commission a declaration from the  
21 property owner or the tenant certifying that the property owner or the Rent Board notified the  
22 tenant of the tenant's right to reoccupy the unit after the temporary eviction and that the tenant  
23 chose not to reoccupy it.

7                   (C) whether the property is an "historical resource" under CEQA;

5                    (Q) whether or not the replacement project would maximize density on the  
6 subject lot; and

7                    (R) if replacing a building not subject to the Residential Rent Stabilization  
8 and Arbitration Ordinance, whether the new project replaces all of the existing units with new  
9 Dwelling Units of a similar size and with the same number of bedrooms.

10                    (5) **Removal of Unauthorized Units.** In addition to the criteria set forth in  
11 subsections (g)(1) through (g)(4) above, the Planning Commission shall consider the criteria below in  
12 the review of applications for removal of Unauthorized Units:

13                    (A) whether the Unauthorized Unit or Units are eligible for legalization  
14 under Section 207.3 of this Code;

15                    (B) whether the costs to legalize the Unauthorized Unit or Units under the  
16 Planning, Building, and other applicable Codes is reasonable based on how such cost compares to the  
17 average cost of legalization per unit derived from the cost of projects on the Planning Department's

24 Section 5. The Building Code is hereby amended by revising Section 102A, to read as  
25 follows:

1     **SECTION 102A – UNSAFE BUILDINGS, STRUCTURES OR PROPERTY**

2             All buildings, structures, property, or parts thereof, regulated by this code that are  
3     structurally unsafe or not provided with adequate egress, or that constitute a fire hazard, or  
4     are otherwise dangerous to human life, safety or health of the occupants or the occupants of  
5     adjacent properties or the public by reason of inadequate maintenance, dilapidation,  
6     obsolescence or abandonment, or by reason of occupancy or use in violation of law or  
7     ordinance, or were erected, moved, altered, constructed or maintained in violation of law or  
8     ordinance are, for the purpose of this chapter, unsafe.

9             \* \* \* \*

10            **102A.3 Inspections and Complaints.** The Building Official is hereby authorized to  
11     inspect or cause the inspection of any building, structure or property for the purpose of  
12     determining whether or not it is unsafe in any of the following circumstances:

13            1.     Whenever the Building Official, with reasonable discretion, determines that such  
14     inspection is necessary or desirable.

15            2.     Whenever any person files with the Building Official a complaint from which  
16     there is, in the Building Official's opinion, probable cause to believe that the building, structure  
17     or property or any portion thereof, is unsafe.

18            3.     Whenever an agency or department of the City and County of San Francisco  
19     transmits to the Building Official a written report from which there is, in the opinion of the  
20     Building Official, probable cause to believe that the building, structure or property, or any  
21     portion thereof, is unsafe.

22            Upon the completion of any such inspection and the finding by the Building Official of  
23     any condition which renders the building, structure or property unsafe, the Building Official  
24     shall, within 15 days thereafter, serve a written notice of violation upon the building owner  
25     which shall contain specific allegations, setting forth each condition the Building Official has

1 found which renders the building, structure or property unsafe. The Building Official shall,  
2 within three days of mailing of such notice of violation, post a copy thereof in a conspicuous  
3 place in or upon such building, structure or property and make available a copy of the notice  
4 of violation to each tenant thereof. Such notice shall also set forth the penalties for violation  
5 prescribed in Section 103A of this code. In addition to the civil penalties prescribed in Section  
6 103A, the Department's cost of preparation for and appearance at the hearing required by  
7 Section 102A.4, and all prior and subsequent attendant and administrative costs, shall be  
8 assessed upon the property owner monthly, after failure to comply with a written notice of  
9 violation that has been served upon the property owner. Said violations will not be deemed  
10 legally abated until the property owner makes full payment of the assessment of costs to the  
11 Department of Building Inspection. See Section 110A, Table 1A-D – Standard Hourly Rates  
12 and Table 1A-K – Penalties, Hearings, Code Enforcement Assessments – for the applicable  
13 rate. Failure to pay the assessment of costs shall result in tax lien proceedings against the  
14 property per Section 102A.18.

15 If the unsafe conditions observed on the property have not been corrected within the  
16 time period provided, the matter shall be set for hearing within 60 days from the compliance  
17 date specified on the notice of violation, if not substantial progress in abating the Code  
18 violations has commenced.

19 102A.3.1. Dwelling Units constructed or installed without required permit(s). In the case of an  
20 unauthorized Dwelling Unit constructed or installed in an existing building without the required permit  
21 or permits, in addition to the above requirements the written notice of violation shall order the property  
22 owner to file an application for a building and other permits required to legalize the unit pursuant to  
23 Building Code Section 106A.3.1.3 and Planning Code Section 207.3 unless removal of the unit is  
24 approved by the Planning Commission pursuant to Planning Code Section 317.

1                   102A.3.1.1. Re-issuance of an unabated notice of violation. Any notice of violation issued  
2 prior to the effective date of Section 102A.3.1 and that remains unabated shall be re-issued in

5                   Section 6. Effective Date. This ordinance shall become effective 30 days after  
6 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
7 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
8 of Supervisors overrides the Mayor’s veto of the ordinance.

10                   Section 7. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
11 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
12 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
13 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
14 additions, and Board amendment deletions in accordance with the “Note” that appears under  
15 the official title of the ordinance.
