3 **Resolution enacting and rescinding parking regulations at various locations.**
4

5 RESOLVED, that, in accordance with the provisions of the California Vehicle
6 Code and the San Francisco Traffic Code, the following regulations governing the
7 parking of vehicles are hereby enacted or rescinded as designated below:

8 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

9 La Salle Avenue, north side, along the bulb-out across from the entrance to
10 Osceola Lane (65 feet);

11 La Salle Avenue, north side, along the bulb-out at the entrance to Gloria R. Davis
12 School (108 feet);

13 La Salle Avenue, south side, along the western bulb-out curb return at the
14 closed-off portion of Osceola Lane (31 feet);

15 La Salle Avenue, south side, along the western and eastern bulb-out curb returns
16 at Whitfield Lane (40 feet and 34 feet, respectively); and

17 La Salle Avenue, north side, along the bulb-out contiguous to Ingalls Street
18 (64 feet).

19 **TOW-AWAY, NO STOPPING, 7 AM - 5 PM SCHOOL DAYS - RESCIND**

20 **TOW-AWAY, NO STOPPING, 7 AM - 6 PM SCHOOL DAYS - ESTABLISH**

21 Washington Street, south side, between Stockton and Powell Streets.

22 **TOW-AWAY NO STOPPING ANYTIME - ESTABLISH**

23 Monterey Boulevard, north side, at Circular Avenue, from the west end of the
24 driveway of 66 Monterey Boulevard to the east end of the driveway of
25 76 Monterey Boulevard.

ANGLE PARKING - RESCIND

Point Lobos Avenue, from 17 feet west of the eastern edge of 1090 Point Lobos
Avenue to 80 feet easterly.

**RESIDENTIAL PERMIT PARKING AREA "N" (2-HOUR TIME LIMIT, 9 AM - 6 PM,
MONDAY THROUGH FRIDAY) - ESTABLISH**

1 14th Avenue, both sides, between Anza Street and Geary Boulevard (400 block);
2 and
3 Cabrillo Street, both sides, between 14th and 15th Avenues (1300 block).

4 **RESIDENTIAL PERMIT PARKING AREA "Z" (2-HOUR TIME LIMIT, 8 AM - 6 PM,**
5 **MONDAY THROUGH FRIDAY) - ESTABLISH**

6 Church Street, both sides, between 26th and Cesar Chavez Streets (a portion of
7 the 1400 block).

8 **RESIDENTIAL PERMIT PARKING AREA "O" (2-HOUR TIME LIMIT, 8 AM - 6 PM,**
9 **MONDAY THROUGH FRIDAY) - ESTABLISH**

10 20th Avenue, west side, between Ulloa and Vicente Streets (2500 block).

11 **RESIDENTIAL PERMIT PARKING AREA "R" (2-HOUR TIME LIMIT, 9 AM - 6 PM,**
12 **MONDAY THROUGH SATURDAY) - ESTABLISH**

13 Willow Street, south side (odd numbers only), between Buchanan and Laguna
14 Streets (600 block); and

15 *Note: Signs will not be posted on this block because of the No Parking*
16 *restrictions, but residents will be able to purchase permits.*

17 1200 and 1300 blocks of Buchanan Street, east side (even numbers only),
18 between Larch Way and Willow Street.

19 *Note: Signs will not be installed on the 1200 block of Buchanan Street until the*
20 *parking occupancy of 80% is met, but residents will be able to purchase*
21 *permits.*

22 **RESIDENTIAL PERMIT PARKING AREA "J" (2-HOUR TIME LIMIT, 8 AM - 5 PM,**
23 **MONDAY THROUGH FRIDAY) - ESTABLISH**

24 Stanyan Street, both sides, between Belgrave Avenue and Rivoli Street.

25 **RESIDENTIAL PERMIT PARKING AREA "S" (2-HOUR TIME LIMIT, 8 AM - 9 PM,**
MONDAY THROUGH FRIDAY) - ESTABLISH

Hickory Street, south side, between Gough and Octavia Streets; and

Lily Street, both sides, between Gough and Octavia Streets.

Note: "No Parking Anytime" signs will not be removed from the north side of Lily
Street, but residents will be able to purchase permits).

1 **RESIDENTIAL PERMIT PARKING AREA "W" (2-HOUR TIME LIMIT, 8 AM - 6 PM,**
2 **MONDAY THROUGH FRIDAY) - ESTABLISH**

3 23rd Street, both sides, between Carolina and De Haro Streets.

4 **TWO-HOUR PARKING, 7 AM TO 6 PM, EXCEPT SUNDAY - RESCIND**
5 **RESIDENTIAL PERMIT PARKING AREA "U" (2-HOUR TIME LIMIT, 8 AM - 10 PM,**
6 **MONDAY THRU SUNDAY) - ESTABLISH**

7 Chesley Street, east side, between Harrison Street and southern terminus.

8 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

9 Noe Street, east side, from 17th Street to Market Street;

10 14th Street, south side, between Buena Vista Terrace and Roosevelt Way; and

11 Treat Avenue, west side, from the southern limit of the 1602 Treat Avenue
12 curb-cut to the southern terminus of Treat Avenue.

13 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

14 Treat Avenue, between the driveways of 1609 and 1615 Treat Avenue (25-foot
15 zone).

16 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

17 164 Lucky Street, west side, from 171 feet to 198 feet north of 26th Street (27-foot
18 zone).

19 **NO PARKING ANYTIME - RESCIND**

20 167 Lucky Street, east side, between the north and south property lines.

21 **NO PARKING, 6 PM TO 8 PM, EXCEPT SATURDAY AND SUNDAY - RESCIND**

22 Harrison Street, west side, from 15th Street to 180 feet northerly.

23 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

24 Baker Street, east side, between the driveways of 420 and 430 Baker Street
25 (6-foot zone).

620-624 - 6th Avenue, east side, from 129 feet to 134 feet south of Balboa Street
(One space between driveways in front of 624 - 6th Avenue only. The
remainder of the curb to be painted red.)

ANGLE (60-DEGREE ANGLE) PARKING - ESTABLISH

1 Randolph Street, north side, from 72 feet west of Arch Street to 115 feet west of
2 Arch Street.

3 **TOW-AWAY, NO STOPPING ANYTIME - RESCIND**
4 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

5 Kaplan Lane, east side, from Clementina Street to the northern terminus.

6 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

7 Opposite Frontage of 1351-1355 De Haro Street (within area currently marked
8 unofficially for No Parking).

9 **NO PARKING ANYTIME - ESTABLISH**

10 Panama Street, both sides, west of Niantic Avenue to the terminus.

11 **NO PARKING ANYTIME 9 AM to 2 PM, EXCEPT SUNDAYS - RESCIND**
12 **NO PARKING ANYTIME, 8 AM TO 4 PM, SCHOOL DAYS - ESTABLISH**

13 Phelan Avenue, west side, between Flood and Staples Avenues.

14 **TWO-HOUR PARKING, 8 AM TO 4 PM, EXCEPT SUNDAYS - RESCIND**
15 **TWO-HOUR PARKING, 8 AM TO 4 PM, SCHOOL DAYS - ESTABLISH**

16 Montecito Avenue, south side, from Plymouth Avenue to Hazelwood Avenue.

17 **TWO-HOUR PARKING, 8 AM TO 4 PM, EXCEPT SUNDAYS - RESCIND**
18 **TWO-HOUR PARKING, 8 AM TO 4 PM, SCHOOL DAYS - ESTABLISH**

19 Hazelwood Avenue, east side, from Staples Avenue to Judson Avenue.

20 **TWO-HOUR PARKING, 8 AM TO 4 PM, EXCEPT SUNDAYS - RESCIND**
21 **TWO-HOUR PARKING, 8 AM TO 4 PM, SCHOOL DAYS - ESTABLISH**

22 Greenwood Avenue, south side, from Plymouth Avenue to Hazelwood Avenue.

23 **TWO-HOUR PARKING, 7 AM TO 6 PM, EVERYDAY - RESCIND**
24 **TWO-HOUR PARKING, 7 AM TO 6 PM, SCHOOL DAYS - ESTABLISH**

25 Colon Avenue, both sides, from Greenwood Avenue to Terminus.

TWO-HOUR PARKING, 8 AM TO 4 PM, EXCEPT SUNDAYS - RESCIND
TWO-HOUR PARKING, 8 AM TO 4 PM, SCHOOL DAYS - ESTABLISH

Valdez Avenue, east side, from Monterey Boulevard to Greenwood Avenue.

1 TWO-HOUR PARKING, 8 AM TO 4 PM, EXCEPT SATURDAYS AND SUNDAYS -
2 RESCIND
3 PARKING HOURS, 8 AM TO 4 PM, SUNDAYS AND HOLIDAYS EXCEPTED -
4 RESCIND
5 TWO-HOUR PARKING, 8 AM TO 4 PM, SCHOOL DAYS - ESTABLISH

6 Hazelwood Avenue, east side, from Monterey Boulevard to Staples Avenue.

7 Categorically exempt from Environmental
8 Review Class 1(c)(9) changes in the traffic and
9 parking regulations where such changes do not
10 establish a higher speed limit or result in more
11 than a negligible increase in the use of the
12 street.

La Salle Avenue, north side, along the bulb-out across from the entrance to Osceola Lane (65 feet);
La Salle Avenue, north side, along the bulb-out at the entrance to Gloria R. Davis School (108 feet);
La Salle Avenue, south side, along the western bulb-out curb return at the closed-off portion of
Osceola Lane (31 feet);
La Salle Avenue, south side, along the western and eastern bulb-out curb returns at Whitfield Lane
(40 feet and 34 feet, respectively); and
La Salle Avenue, north side, along the bulb-out contiguous to Ingalls Street (64 feet).

ANGLE PARKING - RESCIND

Point Lobos Avenue, from 17 feet west of the eastern edge of 1090 Point Lobos Avenue to 80 feet
easterly.

**RESIDENTIAL PERMIT PARKING AREA "N" (2-HOUR TIME LIMIT, 9 AM - 6 PM, MONDAY
THROUGH FRIDAY) - ESTABLISH**

14th Avenue, both sides, between Anza Street and Geary Boulevard (400 block); and
Cabrillo Street, both sides, between 14th and 15th Avenues (1300 block).

**RESIDENTIAL PERMIT PARKING AREA "Z" (2-HOUR TIME LIMIT, 8 AM - 6 PM, MONDAY




