3 **Resolution approving a schedule of fees to be charged by the Department of Consumer**
4 **Assurance for testing of weighing and measuring devices initiated by written request**
5 **and for reinspecting, retesting and recertifying weighing and measuring devices found**
6 **to be outside the tolerances or specifications set by the California Department of Food**
7 **and Agriculture upon an initial inspection prescribed by California Business and**
8 **Professions Code Section 12210(a), and ratifying any such fees charged by the**
9 **Department prior to this resolution.**

11 WHEREAS, The Board of Supervisors has authorized the Department of Consumer
12 Assurance under San Francisco Administrative Code Section 1.15.1(b) and (c) to establish a
13 schedule of fees for testing of weighing and measuring devices initiated by written request
14 and for reinspecting, retesting and recertifying weighing and measuring devices found to be
15 outside the tolerances or specifications set by the California Department of Food and
16 Agriculture upon an initial inspection prescribed by California Business and Professions Code
17 Section 12210(a); and

18 WHEREAS, Pursuant to Section 12210.5 of the California Business and Professions
19 Code and San Francisco Administrative Code Section 1.15.1(b), the fee schedule adopted by
20 the Department of Consumer Assurance shall be in accordance with those fees established
21 by the Director of Agriculture of the State of California; and

22 WHEREAS, The fees established by the Director of Agriculture of the State of
23 California in DMS Notice D-99-7 are on file with the Clerk of the Board of Supervisors in File
24 No. 021314, and are hereby declared to be a part of this resolution as if set forth
25 fully herein; and

1 WHEREAS, The following schedule of fees to be charged by the Department of
2 Consumer Assurance are found to be in accordance with the fees established by the Director
3 of Agriculture of the State of California; and

4 WHEREAS, Pursuant to San Francisco Administrative Code Section 1.15.1(b), the fee
5 schedule adopted by the Department of Consumer Assurance and any changes to the fee
6 schedule must be ratified by resolution of the Board of Supervisors; now, therefore, be it

7 RESOLVED, That the Department of Consumer Assurance may charge the following
8 schedule of fees for testing of weighing and measuring devices initiated by written request
9 and for reinspections, retesting and recertification of weighing and measuring devices that are
10 found to be outside the tolerances or specifications set by the California Department of Food
11 and Agriculture upon an initial inspection prescribed by California Business and Professions
12 Code Section 12210(a):

14 (All charges to be on a portal-to-portal basis plus mileage charges as indicated)

15 Small Capacity Scales: \$70/hour + \$1.00/mile (up to 10,000 GVW)

16 Large Capacity Scales: \$85/hour + \$1.50/mile (10,000 to 40,000 GVW)

17 Scales over 3,000 lbs. capacity: \$125/hour + \$2.00/mile (more than 40,000 GVW)

18 Retail Gasoline Dispensers: \$53/hour + \$0.50/mile

19 Wholesale Petroleum Meters: \$65/hour + \$0.75/mile

20 Liquefied Petroleum Gas Meters: \$65/hour + \$0.75/mile

21 All Other Commercial Devices: \$65/hour + \$0.75/mile; and be it

22 FURTHER RESOLVED, That any fees charged in accordance with this fee schedule
23 by the Department of Consumer Assurance prior to this resolution for testing of weighing and
24 measuring devices initiated by written request and for reinspecting, retesting and recertifying
25 weighing and measuring devices found to be outside the tolerances or specifications set by

1 the California Department of Food and Agriculture upon an initial inspection prescribed by
2 California Business and Professions Code Section 12210(a) are hereby ratified.






