

1 [Extension of Lease to AT&T]

2 **URGING UCSF TO GRANT AN EXTENSION OF A LEASE AGREEMENT OF PROPERTY**
3 **LOCATED AT 1855 FOLSOM STREET TO AT& T BROADBAND TO ALLOW SUFFICIENT**
4 **TIME TO RELOCATE. TO A NEW LOCATION**

5 WHEREAS, AT&T Broadband utilizes the broadcast studios located at 1855 Folsom
6 Street to televise shows related to local City politics, business and health; and

7 WHEREAS, The six shows that are currently televised include the "Mayor's Show"
8 featuring the Mayor of San Francisco, "Ammiano Retorts", featuring the President of the Board
9 of Supervisors, "San Francisco Politics" which features interviews with various local officials,
10 "San Francisco Business" which discusses local business trends, "AIDS Update" which
11 discusses the latest development of the HIV epidemic, as well as City Desk which features
12 reports and panel discussion between reporters of the major local news agencies ; and

13 WHEREAS, UCSF , property owner of 1855 Folsom Street, granted a two month
14 extension to AT&T on October 18, 2000 through December 31, 2000; and

15 WHEREAS, AT&T has until December 15, 2000 to remove all broadcasting equipment;
16 and

17 WHEREAS, UCSF has made no plans to occupy the property for another year; and

18 WHEREAS, The six aforementioned six shows provide an important source of
19 information to citizens of San Francisco as well as to the larger general public; and

20 WHEREAS, It is the intention of the City and County of San Francisco to continue and
21 fund such shows in order to better inform its Citizens of current local events; now therefore be




