3 **Resolution determining that the issuance of a type 42 on-sale beer and wine**  
4 **public premises license to Daniel Kahn, for The Bargain Bank located at 566**  
5 **Minnesota Street, will serve the public convenience and necessity of the people**  
6 **of the City and County of San Francisco, in accordance with Section 23958.4 of**  
7 **the California Business and Professions Code, with conditions.**

9 WHEREAS, Daniel Kahn is seeking issuance of a type 42 on-sale beer and wine  
10 public premises license for The Bargain Bank, located at 566 Minnesota Street; and,

11 WHEREAS, The City Planning Department has verified that the area is properly  
12 zoned; and

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the issuance of a type 42  
18 on-sale beer and wine public premises license, to Daniel Kahn for The Bargain Bank,  
19 located at 566 Minnesota Street will serve the public convenience and necessity of the  
20 people of the City and County of San Francisco.

21 Conditions: (1) No noise shall be audible beyond the area under control of the  
22 licensee; (2) Petitioners shall not permit their patrons or the general public to loiter or  
23 congregate on the sidewalks adjacent to the licensed premises. Patrons standing in line  
24 to enter the premises shall not be considered loitering or unlawfully gathering; (3)The  
25 petitioners(s) shall be responsible for maintaining free of litter the area adjacent to the

1 premises over which they have control; (4) Sale and service of alcoholic beverages  
2 shall be allowed between the hours of 9:00 a.m. and 9:00 p.m. each day of the week.




