3 **Ordinance authorizing settlement of the lawsuit filed by Frank Mufarreh against the City**
4 **and County of San Francisco for \$65,000; the lawsuit was filed on March 12, 2024, in**
5 **San Francisco Superior Court, Case No. CGC-24-613026; entitled Frank Mufarreh v. City**
6 **and County of San Francisco, et al.; the lawsuit involves alleged personal injury arising**
7 **from a fall on a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Frank Mufarreh v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-24-613026 by the
13 payment of \$65,000. The lawsuit involves alleged personal injury arising from a fall on a City
14 sidewalk.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 March 12, 2024, and the following parties were named in the lawsuit: Plaintiff Frank Mufarreh;
17 Defendants: City and County of San Francisco, Timoleon Zaracotas as Trustee of the
18 Timoleon and Corinne Zaracotas Living Trust.
