

10 from the owners of those properties as shown on said list marked as Table I Project Scope, a copy of  
11 which is on file with the Clerk of the Board of Supervisors in file no. 991720, and be it

12 **FURTHER RESOLVED**, That the total cost to acquire said easements shall not exceed \$220,472,  
13 with each easement to automatically expire 20 years from the date of recordation of each respective  
14 deed, and, be it

15 **FURTHER RESOLVED**, Said noise easement program is in conformity with the County of San  
16 Mateo's master planning process and public works projects.






