5 WHEREAS, Joseph E. Illick III has resided in San Francisco for almost 50 years; and

6 WHEREAS, Joe is Professor Emeritus of San Francisco State University, having
7 taught there during the period of 1963-2002 and

8 WHEREAS, Joe is the author of five books and numerous articles and book reviews
9 on American history subjects, the most recent being American Childhoods (2002), and is also
10 the recipient of many awards and honors for his work in academia, and

11 WHEREAS, Joe is a founder of the Marian Wright Edelman Institute for the Study of
12 Children, Youth, and Families at San Francisco State University, and

13
14 WHEREAS, Joe has served the San Francisco community in many other roles,
15 including Court-Appointed Special Advocate for foster children; Board of Directors, Friends of
16 J. Paul Leonard Library, San Francisco State University; and Board Of Governors, Dolphin
17 Swimming and Boating Club, and

18 WHEREAS, Joe is an esteemed member of San Francisco's historic Dolphin
19 Swimming and Boating Club, where he has been recognized as the Most Inspirational
20 Swimmer, and is the only senior known to have won the Dolphin Club's annual and highly
21 competitive Polar Bear Swim competition, and

23 WHEREAS, Joe is the oldest person to have swum from Alcatraz to Aquatic Park on
24 New Year's morning, having done so in 2009 at the age of 74, and

1 WHEREAS, Joe is a valued member of the San Francisco Ocean Film Festival
2 volunteer team, serving as a volunteer to the non-profit festival since its beginning, and as a
3 Founding Board of Directors member beginning in 2004 through the 6th annual festival in
4 2009, and

5 WHEREAS, Joe has created many memorable works of art, including a series of
6 original woodcuts of U.S. presidents that has been exhibited throughout the Bay Area, now,
7 therefore, be it

8 RESOLVED, That the San Francisco Board of Supervisors congratulates Joe on his
9 many accomplishments and significant service to the San Francisco community; and, be it
