

1 [Study of HIV prevention in beerhalls in Harare, Zimbabwe.]

3 **Resolution authorizing the San Francisco Department of Public Health, AIDS Office**
4 **(SFDPH, AIDS) to enter retroactively into the second year of an agreement with The**
5 **Regents of the University of California San Francisco (UCSF), the primary contractor,**
6 **and to accept and expend funds in the amount of \$39,774 to participate in a**
7 **randomized trial of HIV prevention in beerhalls in Harare, Zimbabwe, for the period of**
8 **May 1, 2003, to April 30, 2004.**

10 WHEREAS, UCSF is the recipient of a grant award from the DHHS National Institutes
11 of Health (NIH) for the conduct of a program entitled “A Randomized Trial of HIV Prevention in
12 Harare Beerhalls”; and,

13 WHEREAS, It is considered in the best interests of NIH, UCSF, and SFDPH, AIDS to
14 participate in this project; and,

15 WHEREAS, UCSF has agreed to reimburse SFDPH, AIDS in the amount of \$39,774
16 under the terms of the second year of this agreement; and,

17 WHEREAS, As a condition of receiving the funds UCSF requires SFDPH, AIDS to
18 enter into a subcontract (The “Agreement”), a copy of which is on file with the Clerk of the
19 Board of Supervisors in File No. _____, which is hereby declared to be a part of
20 this resolution as if set forth fully herein; and,

21 WHEREAS, The subcontract budget includes provision for indirect costs of \$4,262;
22 and,

23 WHEREAS, This Resolution requires expedited review by the Board of Supervisors
24 because the Department did not receive the UCSF subcontract until May 15, 2003, after the
25 start date of this subcontract; and,

1 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds
2 may be placed automatically on consent agendas in committee, as they are usually
3 considered to be routine items, and this resolution authorizes the acceptance and expenditure
4 of grant funding; now, therefore, be it

5 RESOLVED, That SFDPH, AIDS is hereby authorized to enter retroactively into the
6 second year of a subcontract agreement with UCSF, the primary contractor, and to accept
7 and expend funds in the amount of \$39,774 for services under “A Randomized Trial of HIV
8 Prevention in Harare Beerhalls”; and, be it

9 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
10 agreement on behalf of the City; and, be it

11 FURTHER RESOLVED, That the Controller is directed to designate the position funded
12 under this agreement as a “G” or grant-funded position which would terminate when the
13 agreement expires.
