3 **Resolution approving expenditures from the Budget Savings Incentive Fund for one-**  
4 **time purposes in FY2012-2013 and FY2013-2014.**

5 WHEREAS, Section 10.20 of the San Francisco Administrative Code established a  
6 Budget Savings Incentive Fund to encourage City Departments to implement cost-saving  
7 incentives and allow for the reinvestment of those savings in one-time expenditures that  
8 improve the efficiency of departmental operations, reduce the cost of service delivery,  
9 generate additional revenue, or meet deferred maintenance needs; and

10 WHEREAS, at the close of FY2010-2011, \$8.7 million was deposited into the Fund  
11 from the savings generated by General Fund Departments and the Controller assumes  
12 additional deposits of \$9.6 m from departmental expenditure savings projected for FY2011-  
13 2012, for a total estimated balance of \$18.3 million; and

14 WHEREAS, Departments have made proposals for one-time and efficiency proposals  
15 to the Capital Planning Committee and the Committee on Information Technology; and

16 WHEREAS, through these committees, expenditure proposals have been approved by  
17 the Mayor's Budget Director, the Controller and the President of the Board of Supervisors or  
18 their designees; and

19 WHEREAS, the expenditure proposals of \$8.4 m have been included in the Mayor's  
20 proposed FY2012-2013 budget and \$9.9 m for the FY2013-2014 budget, and a listing is on  
21 file with the Clerk of the Board of Supervisors in File No. 120640, which is hereby declared to  
22 be a part of this resolution as if set forth fully herein; now, therefore, be it






