Ordinance authorizing settlement of lawsuit filed by the City Attorney on behalf of

People of the State of California against FlightCar Incorporated and the Cross-Complaint filed by FlightCar Incorporated against the City and County of San Francisco; for the payment of \$230,000 by FlightCar Incorporated to the City; the underlying lawsuit was filed on May 31, 2013, in San Francisco Superior Court, Case No. CGC-13-531807, entitled People of the State of California v. FlightCar, Inc. and later changed venue to Santa Clara County Superior Court, Case No. 1-13-CV-251634: FlightCar Incorporated's Cross-Complaint, entitled FlightCar Incorporated v. City and County of San Francisco, with the same case number, was filed on February 4, 2014.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action and cross-complaint entitled People of the State of California against FlightCar Incorporated and FlightCar Incorporated v. City and County of San Francisco, Santa Clara Superior Court, Case No. 1-13-CV-251634 for the payment of \$230,000 by FlightCar Incorporated to the City and County of San Francisco. Additional settlement terms include a requirement that FlightCar Incorporated apply for and secure a permit as an Off-Airport Rental Car Company with San Francisco International Airport.

The above-named complaint was filed in San Francisco Superior Court on May 31, 2013 and then changed venue to Santa Clara County Superior Court; the cross-complaint was filed in Santa Clara County Superior Court; the following parties were named in these actions: People of the State of California (Plaintiff), FlightCar Incorporated (Defendant and Cross-Complainant), and City and County of San Francisco (Cross-Defendant). The San Francisco International Airport and John L. Martin were both initially named as Cross-Defendants, but were dismissed by Cross-Complainants.
