The India Basin is such an important, vital, beautiful and caring project and will do so, so much for the people of the Bayview Neighborhood as well as the greater San Francisco population... As one of the co-chairs of the India Basin Fundraising Campaign, I am encouraging you to recognize the very important role that the Park will play and is already playing.

Great cities build great parks in every neighborhood, so it is wonderful that the Recreation and Park Department and its non-profit partners are committed to bringing the best quality open space and recreational facilities to the Bayview. Accepting this second round of private funding for the Initiative is especially important at this moment of economic uncertainty because it allows the city to turn \$125 million in public funding into a \$200 million investment in community infrastructure, services and programming.

The waiver is important because raising \$75 million in private funding is hard and there are potential funders who may personally or through their companies have relations with the city. The waivers will allow Department staff and the Mayor to discuss the project with such funders and the agreements hold the entire Initiative to a very high level of donor transparency.
