3 **Resolution declaring November 18, 2025, as In-Home Supportive Services Provider Day**
4 **in the City and County of San Francisco.**

6 WHEREAS, In-Home Supportive Services (IHSS) providers play a vital role in
7 supporting seniors and people with disabilities in San Francisco County, ensuring they can
8 live with dignity and independence in the comfort of their own homes; and

9 WHEREAS, Within San Francisco County, there are 26,000 dedicated IHSS providers
10 who deliver high-quality care to low-income residents and save taxpayers millions of dollars
11 each year when compared to more costly tax funded institutional care; and

12 WHEREAS, The diligent work of in-home caregivers - the majority of whom are women
13 of color and immigrants - often goes unnoticed, along with the financial struggles they and
14 their families endure to provide this essential service to those in need; and

15 WHEREAS, IHSS providers devote their time, compassion, and expertise to assist
16 those in need with a spectrum of support from essential daily activities to critical and intimate
17 care service, enabling consumers to maintain their health, well-being and highest level of
18 independence; and

19 WHEREAS, IHSS providers demonstrate unwavering dedication to enhancing the
20 quality of life for members of the community, often going above and beyond their duties to
21 provide emotional support and companionship to their clients; and

22 WHEREAS, The month of November is designated as National Family Caregivers
23 Month, which offers the opportunity to highlight the hard work and dedication in-home
24 caregivers exemplify every day in caring for both family and non-family members; now,
25 therefore, be it

1 RESOLVED, That the Board of Supervisors appreciates the essential contributions of
2 in-home caregivers and will work with them to protect programs and services such as IHSS,
3 keep a fundamental commitment to our low-income seniors and disabled residents, and ask
4 the State of California and the Federal Government to maintain a commitment to advancing
5 quality care and ensuring IHSS providers have quality jobs; and, be it

6 FURTHER RESOLVED, That in honor of the invaluable contributions of In-Home
7 Supportive Service providers; to acknowledge their commitment to fostering a more
8 compassionate and inclusive community; and to recognize the essential contributions IHSS
9 providers deliver to low-income seniors and disabled residents, the Board of Supervisors of
10 the City and County of San Francisco hereby declares November 18, 2025, as In-Home
11 Supportive Services Providers Day in San Francisco.
