
Dear Mr. Gebb:

11 WHEREAS, Center for New Music, Inc. is seeking the issuance of a Type-64
12 special on-sale general theater liquor license to do business as the Center for New
13 Music, located at 55 Taylor Street (District 6); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of
17 support with the Department of Alcoholic Beverage Control under California Business
18 and Professions Code, Section 24013, and recommends that the Department of
19 Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort
22 to prevent the loitering of persons on any property adjacent to the licensed premises as
23 depicted on ABC-253 dated March 14, 2019; 2) The petitioner(s) shall be responsible
24 for maintaining free from litter the area adjacent to the premises over which they have

1 control, as depicted on ABC-253 dated March 14, 2019; and 3) No noise shall be
2 audible at any nearby residence; now, therefore, be it

3 RESOLVED, That in accordance with California Business and Professions Code,
4 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
5 hereby determines that the issuance of a Type-64 special on-sale general theater liquor
6 license to the Center for New Music, Inc., doing business as the Center for New Music,
7 located at 55 Taylor Street, will serve the public convenience or necessity of the City
8 and County of San Francisco; and, be it

9 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
10 San Francisco hereby endorses and adopts the recommendations of the Police
11 Department listed above and recommends that the Department of Alcoholic Beverage
12 Control issue the license with those conditions.


