10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Pacific Bell Telephone Company v.
12 City and County of San Francisco, San Francisco Superior Court, Case No. CGC-19-581035
13 by the payment of \$72,036. The lawsuit involves alleged property damage caused by flooding
14 due to a water main break.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 November 25, 2019, and the following parties were named in the lawsuit: Plaintiff Pacific Bell
17 Telephone Company and Defendant City and County of San Francisco.
