

1 [Assembly Bills 1823 and 2058 and State Senate Bill 1870]

2 **Resolution opposing State Assembly Bills 1823 and 2058, and Senate Bill 1870 (as**  
3 **drafted), regarding management and operation of the City's regional water system and**  
4 **requesting the Mayor to transmit communication of such opposition to the State**  
5 **Legislature.**

7 WHEREAS, The San Francisco Public Utilities Commission (SFPUC) is a department  
8 of the City and County of San Francisco that provides water, wastewater, and municipal  
9 power services to San Francisco; and

10 WHEREAS, The SFPUC under contractual agreement with 29 wholesale water  
11 agencies, supplies water to 1.6 million additional customers within three Bay Area counties -  
12 Santa Clara, Alameda and San Mateo counties; and

13 WHEREAS, Assembly Bill 1823, Assembly Bill 2058 and Senate Bill 1870 would impair  
14 the existing contractual agreement between San Francisco and its wholesale suburban  
15 customers; and

16 WHEREAS, These bills would abrogate the City's discretion in choosing how to  
17 implement its Capital Improvement Plan (CIP) to construct projects in its regional water  
18 system; and

19 WHEREAS, These bills would under certain circumstances convey from San Francisco  
20 to the State the City's discretion to operate and maintain its regional water supply system; and

21 WHEREAS, The City and County of San Francisco is developing a plan for the  
22 financing of the CIP for voter consideration in November; now, therefore be it

23 RESOLVED, That the City and County of San Francisco opposes State Assembly Bills  
24 1823 and 2058 regarding management and operation of the City's regional water system; and  
25 be it

1 FURTHER RESOLVED, That the City and County of San Francisco opposes State  
2 Senate Bill 1870 as currently drafted; and be it

3 FURTHER RESOLVED, That the Mayor transmit communication of such opposition to  
4 the State Legislature.
