14 Section 1. Article 12C of Part III of the San Francisco Municipal Code is hereby
15 amended by amending Section 1102.1, to read as follows:

16 Sec. 1102.1. Assessor's Parcel Numbers.

17 Every document pertaining to real property that is submitted for recordation shall show
18 on the face of the document the Assessor's correct parcel number, or numbers, and the
19 commonly-known situs and/or street name and number of the real property described therein.


