14	Section 1. The Board of Supervisors hereby adopts and implements the Second
15	Amendment to the 2024-2027 Memorandum of Understanding ("MOU") between the City and
16	County of San Francisco and Service Employees International Union, Local 1021, Staff and
17	Per Diem Nurses to address order of selection for filling vacant nurse positions.

21	Section 2. The Board of Supervisors hereby authorizes the Department of Human
22	Resources to make non-substantive ministerial or administrative corrections to the MOU.
