5	WHEREAS, The death of a mother during or within the following year of a pregnancy
6	from a pregnancy-related complication is called pregnancy-related mortality; and
7	WHEREAS, The number of pregnancy-related deaths for every 100,000 live births, or
8	the pregnancy-related mortality ratio, is often used as an indicator to measure the health and
9	well-being of a nation and a municipality; and
10	WHEREAS, In San Francisco, there is one pregnancy-related death each year; and
11	WHEREAS, In San Francisco, the top three causes of maternal death are embolism,
12	infection, and chronic disease, including cancers and hypertension, which in turn are
13	associated with economic, cultural, environmental and social conditions; and
14	WHEREAS, 45% of Black/African American birthing mothers live below the federal
15	poverty line in San Francisco; and
16	WHEREAS, Inordinate and unacceptable disparities exist in the rate of pregnancy-
17	related mortality by race and ethnicity, and
18	WHEREAS, In San Francisco, Black/African American birthing mothers experience a
19	disproportionate share of pregnancy-related deaths; and
20	WHEREAS, Over the past 10 years, Black/African American birthing mothers had
21	about 4% of births but accounted for 50% of pregnancy-related deaths; and
22	WHEREAS, The Maternal, Child and Adolescent Health section of the Department of
23	Public Health has convened a group of multi-sector stakeholders to participate in the Perinatal
24	Equity Initiative to implement strategies to decrease disparities in maternal mortality, preterm
25	birth, and other perinatal health issues; and
