9 WHEREAS, A hearing was held at the Governmental Audit and Oversight Committee  
10 (GAO) in February 2024 on the Controller’s audit findings and grant agreements between SF  
11 SAFE and the San Francisco Police Department; and

12 WHEREAS, At that hearing, the Controller’s Office reported on their limited scope  
13 assessment of the fulfillment of the grant agreement; and

14 WHEREAS, Under the auspices of the SFPD and the governance of the SF SAFE  
15 Board of Director, notably Pres. Daniel Lawson and Chief Financial Officer Tom Yeh, former  
16 Executive Director Worthy subsequently been criminally charged with 34 felony counts,  
17 including theft, grand theft, and misappropriation of public funds related to SF SAFE; now,  
18 therefore, be it

19 MOVED, That pursuant to its authority under Charter, Section 16.114, and Government  
20 Code, Sections 25170 and 37104, the Board of Supervisors hereby directs the Clerk of the  
21 Board to issue a subpoena duces tecum requiring Mr. Lawson and Mr. Yeh to attend a future  
22 GAO hearing, date to be determined, should they fail to attend and answer questions at  
23 special meeting hearing at 10:00 a.m. on October 11, 2024, to provide oral information and  
24 respond to questions regarding their participation in and knowledge and oversight of financial  
25 activities of SF SAFE.
