

1 [Civil Filing And Appearance Fees For Operation Of The Law Library]
2 INCREASING CIVIL FILING AND APPEARANCE FEES PROVIDED IN BUSINESS AND
3 PROFESSIONS CODE SECTIONS 6321, 6322 AND 6322.1 FOR OPERATION OF THE
4 LAW LIBRARY.

6 WHEREAS, The Law Library's filing fee income is inadequate to
7 meet present and anticipated future operating costs of the Law
8 Library; legal publication costs, salaries and general operating
9 expenses have increased and are expected to increase yearly, and
10 automated reference resources and library systems must be acquired
11 and maintained; so that an increase in the filing and appearance fees
12 pursuant to Section 6322.1 of the Business and Professions Code of
13 the State of California fund Law Library operations is required; and,

14 WHEREAS, California Business and Professions Code section 6322.1
15 empowers this Board of Supervisors to increase Law Library civil
16 filing fees from \$24.00 to \$27.00 by excluding the increase from the
17 definition of "total fee" provided in sections 26820.6 and 72055 of
18 the Government Code; and,

19 WHEREAS, The increased fee does not affect the City and County
20 General Fund or the Trial Court Trust Fund established by Government
21 Code section 68085; now, therefore, be it

22 RESOLVED, That the Board of Supervisors of the City and County
23 of San Francisco hereby orders that the fees for use of the Law
24 Library, provided in sections 6321 and 6322 of the California
25 Business and Professions Code be increased from \$24.00 to \$27.00 in

1 San Francisco Superior Court, unlimited jurisdiction and limited
2 jurisdiction civil division, effective January 1, 2000; and, be it

3 FURTHER RESOLVED, That pursuant to Government Code section
4 6322.1, the three dollar (\$3.00) increase in Law Library filing fees
5 is specifically excluded from the definition of "total filing fee" in
6 the above-referenced provisions of the Government Code, and
7 therefore, that three dollars (\$3.00) of the fee be added to the
8 total filing fees in San Francisco Superior Court, unlimited
9 jurisdiction and limited jurisdiction civil division; and, be it

10 FURTHER RESOLVED, That the Superior Court, unlimited
11 jurisdiction and limited jurisdiction civil division, of the City and
12 County of San Francisco is hereby authorized and directed to collect
13 the sum of \$27.00 in San Francisco Superior Court, unlimited
14 jurisdiction and limited jurisdiction civil division, for the use of
15 the Law Library, for each filing and appearance described in Sections
16 6321 and 6322 of said code, from January 1, 2000, and to pay the same
17 over to the Treasurer of the San Francisco Law Library in the manner
18 provided by law; and, be it

19 FURTHER RESOLVED, That the Clerk of the Board of Supervisors be
20 and is hereby directed to deliver copies of this resolution, duly
21 certified, to the Superior Court, unlimited jurisdiction and limited
22 jurisdiction civil division, of the City and County of San Francisco.




