I am the Executive Director of the San Francisco Community Land Trust (SFCLT), where I work to advance permanently affordable housing, prevent displacement, and support community stewardship of land in San Francisco. My professional background combines legal expertise, housing policy, nonprofit leadership, and direct experience in real estate acquisition and program development focused on low-income and historically marginalized communities.

My work centers on shared equity housing models—including community land trusts, limited equity housing cooperatives, and small-site acquisition strategies—that serve low-income households, communities of color, seniors, immigrants, and long-term San Francisco residents at risk of displacement. Through my leadership at SFCLT and prior work at Bay Area Community Land Trust, I have collaborated closely with tenants, community-based organizations, labor, advocates, and local governments to address racial and economic inequities in housing access.

I bring a perspective grounded in both lived community engagement and advanced legal and policy training, with a deep understanding of how local governance decisions affect neighborhood stability, affordability, and community control in San Francisco.

I was a resident of San Francisco during my time in law school and lived in the Mission and the Tenderloin. I identify as a woman of color.



At Lendlease, I championed ambitious mixed-use, mixed-income developments, setting a benchmark for the triple-bottom-line approach, balancing environmental sustainability, community well-being, and economic vitality. During my tenure as the OCII Executive Director, I led the revival of iconic districts such as Mission Bay, Transbay, and Hunters Point Shipyard/Candlestick Point, contributing thousands of affordable homes and driving economic revitalization in underinvested communities.

My leadership and track record have earned recognition, including designations such as Most Influential Women in Business from the *San Francisco Business Times* and *Silicon Valley Business Journal*.
