3 **Resolution determining that the issuance of a type 48 on-sale general public**
4 **premise license to Peter Glikshtern on behalf of Aljoy Inc. for Pink located at 2925**
5 **16th Street, will serve the public convenience and necessity of the people of the**
6 **City and County of San Francisco, in accordance with Section 23958.4 of the**
7 **California Business and Professions Code with conditions.**

9 WHEREAS, Peter Glikshtern on behalf of Aljoy Inc. is seeking issuance of a
10 type 48 on-sale general public premise license for Pink, located at 2925 16th Street;
11 and,

12 WHEREAS, The City Planning Department has verified that the area is properly
13 zoned; and

14 WHEREAS, The Police Department recommends that the liquor license
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business
17 and Professions Code, the Board of Supervisors of the City and County of San
18 Francisco hereby determines for the foregoing reasons that the issuance of a type 48
19 on-sale general public premise license, to Peter Glikshtern on behalf of Aljoy Inc. for
20 Pink, located at 2925 16th Street will serve the public convenience and necessity of the
21 people of the City and County of San Francisco.

22 Conditions: (1) No noise shall be audible beyond the area under control of the
23 licensee; (2) Petitioners shall not permit their patron or the general public to loiter or
24 congregate on the sidewalks adjacent to the licensed premises. Patrons standing in
25 line to enter the premises shall not be considered loitering or unlawfully gathering; (3)

1 The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to
2 the premises over which they have control; (4) Sales of alcoholic beverages for
3 consumption off the premises are strictly prohibited; (5) Petitioners shall provide readily
4 identifiable, security personnel during hours of entertainment and shall maintain order
5 within the premises as well as outer areas adjacent to the premises over which
6 petitioners has control and prevent any activity which would interfere with the quiet
7 enjoyment of the property by nearby residents.
