Emi Gusukama, succeeding Martin Schenker, (Seat No. 6, must be an immigrant to the United States who is appointed in accordance with Section 4.101 of the Charter. In addition, members shall have demonstrated knowledge of and interest in the health, human service, educational, or employment issues that affect immigrants residing in San Francisco), for the unexpired portion of a two-year term ending June 6, 2001;

Vram Kouramajian (residency requirement waived), succeeding Lee Sprague, (Seat No. 7, must be an immigrant to the United States who is appointed in accordance with Section

- 1. The membership of the Immigrant Rights Commission has a goal to be representative of the diversity of the City and County of San Francisco.
- Applicant Vram Kouramajian, a new appointee, who is not a resident of San
 Francisco, is a person with experience that uniquely qualifies him/her to serve on
 the Immigrant Rights Commission.
- 3. The Immigrant Rights Commission has attempted to fill the position, for which Vram Kouramajian was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that Vram Kouramajian is qualified to serve on the Immigrant Rights Commission.
- 4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Immigrant Rights Commission at this time; and, be it

FURTHER RESOLVED, That the Board of Supervisors waives the residency requirement for Vram Kouramajian, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
