Hello Ben,

The Bay Area Air Quality Management District Board of Directors has approved all project sites and has also received a concurrence from CARB on the funding percentage we can offer. The evaluation has shown that City & County of San Francisco - Recreation & Park is eligible for CMP funding for the following six projects/sites:

- 24MOY7, Crocker Amazon Playground Maintenance Garage, \$105,033 (3-year project life at 1,440kWh per year)
- 24MOY8, Louis Sutter Playground Maintenance Yard, \$82,807 (3-year project life at 1,440kWh per year)
- 24MOY9, Civic Center Garage Maintenance Area, \$147,619 (3-year project life at 2,160kWh per year)
- 24MOY10, Balboa Park Boxer Stadium, \$231,622 (3-year project life at 2,400kWh per year)
- 24MOY11, Margaret S. Hayward Playground Maintenance Garage, \$163,125 (3-year project life at 2,160kWh per year)
- 24MOY12, McLaren Park Caretakers Cottage, \$32,487 (3-year project life at 480kWh per year)

Please be aware that for the above project sites we are funding 100% of eligible costs but there are line items on the quotes we did not consider as eligible but will still be your responsibility to pay.

If you do not wish to proceed, we will withdraw your application from consideration for funding. Please respond to this notice within 10 business days so we can proceed with the next steps in the process.

IMPORTANT: NO equipment is to be ordered and NO work is to begin on this project until the Air District has completed a pre-inspection AND a fully executed Grant Agreement between the Air District and the grantee is in place. No costs or financial commitments that are incurred or undertaken prior to the date of full execution of the Grant Agreement will be considered for reimbursement from the Air District. Board of Directors approval does not guarantee funding. Only a fully executed Grant Agreement signed by the Air District constitutes an obligation for the Air District to fund a project.
