3 **Resolution supporting AB3042 which protects the child victims of commercial sexual**  
4 **exploitation.**

6 WHEREAS, Every year in San Francisco, thousands of children, as young as 10 years  
7 old, are forced to work in the sex trades; and

8 WHEREAS, San Francisco's Task Force to End the Exploitation of Youth exposed the  
9 increasing victimization of sexually exploited youth; and

10 WHEREAS, Child sexual exploitation is an intolerable public health and public safety  
11 problem; and

12 WHEREAS, District Attorney Kamala D. Harris, working with SAGE and other  
13 community advocates, has developed and sponsored AB3042; and

14 WHEREAS, Assemblyman Leland Yee authored the legislation and it was passed  
15 unanimously by the California State Assembly; and

16 WHEREAS, AB3042 will be considered by the California Senate Appropriations  
17 Committee on August 2, 2004 and then by the full State Senate; and

18 WHEREAS, AB3042 will increase penalties for offenders convicted of sexual crimes  
19 against children and youth when those crimes are committed in the context of commercial  
20 sexual exploitation; and

21 WHEREAS, AB3042 will make clear that these victimized children are in fact victims of  
22 molestation and sexual assault and will not be disregarded as "prostitutes"; and

23 WHEREAS, This cutting-edge legislation, the first of its kind in the nation, will make  
24 clear that prostituted and exploited children will be protected from molestation, abuse and  
25 trauma; now therefore, be it




