15 WHEREAS, The City Planning Department has verified that the area is properly  
16 zoned; and

17 WHEREAS, The Police Department recommends that the liquor license  
18 application be approved with a condition; now, therefore, be it

19 RESOLVED, That in accordance with Section 23958.4 of the California Business  
20 and Professions Code, the Board of Supervisors of the City and County of San  
21 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42  
22 on-sale beer and wine public premises license and the transfer of a Type 20 off-sale  
23 beer and wine license from 223 Valencia Street to 3701 Geary Boulevard Unit #102, to  
24 Philippe and Ellen Gardelle for Hats Off, a boutique wine shop, will serve the public  
25 convenience and necessity of the people of the City and County of San Francisco.

1           Condition: Sales, service or consumption of alcoholic beverages shall be  
2 permitted only between the hours of 9:00 a.m. to 9:00 p.m. each day of the week.


