3 **Resolution urging the Mayor to work with the San Francisco Veterans Community to**  
4 **identify an appropriate place of prominence in City Hall for the 363<sup>rd</sup> Infantry Regiment**  
5 **Battle Flags, and place the flags in this location as soon as possible.**

7 WHEREAS, In 1927, City Hall dedicated three flags associated with "San Francisco's  
8 Own," the 363<sup>rd</sup> Infantry Regiment of the Army's 91<sup>st</sup> Division, which fought during World  
9 War I; and

10 WHEREAS, These flags have been housed in a glass case in front of the Mayor's  
11 Office almost continuously since 1927; and,

12 WHEREAS, Both the flags and the glass case were removed from this location on  
13 September 25, 2000 and sent to the Oakland Conservatory Laboratory for the repair of  
14 several cracks in the case; and,

15 WHEREAS, These treasured artifacts are an important memorial to San Francisco  
16 Veterans and deserve a place of prominence in City Hall; now, therefore, be it

17 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
18 urges the Mayor to work with the veterans community to identify an appropriate place of  
19 prominence in City Hall for the 363<sup>rd</sup> Infantry Regiment Battle Flags; and, be it

20 FURTHER RESOLVED, That these flags be returned to City Hall as soon as possible.




